# Of Covenant Theology: Documenting the Bible's Commandment of Racial Segregation

"Behold it [Israel] is a people that shall DWELL ALONE." - Numbers 23:9

"For thou art an holy people unto Yahweh, your Elohim: Yahweh your Elohim hath chosen thee to be a special people upon Himself, above all the people that are upon the face of the earth." – Deut. 7:6. Hear, ye deaf; and look, ye blind, that ye may see. Who is blind, but my servant? or deaf, as my messenger that I sent? who is blind as he that is perfect (Heb. shalam, safe, comfortable, at peace), and blind as the LORD's servant? Seeing many things, but thou observest not; opening the ears, but he heareth not. – Isa. 42:18-20.

"For there are many unruly and vain talkers and deceivers, especially they of the circumcision: Whose mouths must be stopped, who subvert whole houses, teaching things which they ought not for filthy lucre's sake...wherefore rebuke them sharply...not giving heed to Jewish fables and commandments of men, that turn from the truth. - Titus 1: 10-14.

#### Introduction

The two leading Bible-based theologies in the world today are Judaism and Judeo-Christianity. The systemic errors of these two theologies must be exposed before the Truth can be understood. Even though both of these theologies claim to adhere to the teachings of the Bible, this is not the case. A brief historical survey of how these two theologies came about will first be presented in order to provide an idea of the vastness of the deception that has occurred. Once the true Christian appreciates how these two priesthoods have distorted the Holy Scriptures for filthy lucre's sake, only then can the unlearning of false ideas begin.

#### Judaism

Judaism is based on two gigantic lies: 1.) that Judaism is the religion of the Old Testament, and 2.) that the Jewish people are the Israelites of the Bible. Contrary to Judaism's public claims about its own origins, the fact is that many rabbis, Jewish historians and encyclopedias admit that the true basis of Judaism is not the Bible at all. The true source of Jewish theology is the Talmud.

The Talmud is a mere collection of commentaries on the Bible and other subjects. The rabbis claim that the Talmud is the "oral tradition" of Moses, which was supposedly passed down by "Jewish scribes." Who these people were, the rabbis cannot say. It is a myth. There was no such tradition. The idea is nothing but rabbinical invention, for the purpose of elevating themselves above the very Scriptures they pretend to uphold. The "oral tradition" is the best explanation the rabbis have for this false tradition. Deut. 4:2 explicitly states that no person has the authority to contradict the written Law

of Moses. Hence, any commentaries, which claim to have authority over the written laws of the Bible, are fraudulent, by the Bible's own standards.

The fact is that the Talmud contradicts virtually every law that Moses recorded, so the Talmud is nothing but a mountain of lies heaped up against Scripture. Despite public pronouncements declaring Judaism's faithfulness to the Torah, in the eyes of the Jewish rabbi, the Talmud supercedes the Torah. This is why Yahshua condemns rabbinism as "the tradition of the elders" which makes "the law of none effect." (Matthew 15:6 & all of chapter 23.)

The ethnicity of the Jewish people is also a matter of deception. The Bible is clearly written to a specific group of people, whom Yahweh refers to as His "chosen." The Chosen People are clearly identified in Scripture by their appearance, characteristics, historical exploits and prophetic achievements. The fact is that the Jewish people fit absolutely none of these identifying marks. The Israelites were repeatedly told to remain separate and aloof from all other races and cultures.

Contrary to this dictum, the Jews have always insinuated themselves into other people's lands, having never built a city or country of their own. Like the cuckoo bird, the Jews nest in other people's nests. The Israelites were warned repeatedly that, should they fraternize with other races and cultures, they would lose the very "chosenness" by which He had jealously guarded them. "Learn not the way of the heathen" is the Biblical command. The Israelites were forbidden to circumcise non-Israelites. This was true from Jacob down to the Maccabees, who refused to circumcise non-Israelites. Contrary to the law of separation, the Jews have always taken converts of all races. This is why the Jews are the most miscegenated people on the face of the earth. As you will see from the evidence presented herein, this fact automatically disqualifies them as Yahweh's chosen.

All Jewish scholars admit that up to 95% of modern Jews are a non-Shemitic people, namely the Ashkenazi branch of Jewry, which is descended from the Khazar nation, which CONVERTED to Judaism around 740 AD. These Khazars have never had a single Hebrew, Israelite or Shemitic ancestor. Hence, this branch of Jewry has no right to claim Israelite ancestry, much less the land of Palestine. The other five percent of modern Jews are of Sephardic ancestry. These people are also non-Israelites, but they are the originators of the religion called Judaism. It was the scribes and Pharisees who originated Talmudic doctrine just before the days of Jesus Christ. The New Testament provides ample proof that their doctrine and ethnicity are suspect. The four Gospels condemn their religion on every page, but few Christians are aware of this, because the theology of Judeo-Christianity has withheld this information from them and because most Christians don't read their Bibles, except for the verses selected for them by their Judaized priesthood.

Although the Pharisees began as a Judahite cult during the Maccabean era, the tides of war began to influence their loyalty to Israel. Successive invasions of the land of Judah, which was a racially homogenous nation, divided the nation into sects of dubious loyalty. The Maccabees were the most loyal to the Hebrew traditions, and they maintained their ethnic and theological purity <u>until King John Hyrcanus violated the Mosaic Law by circumcising the males of Idumea</u>. This event occurred in the year 121 BC. These Idumeans were the racially mixed descendants of Esau, the perpetual enemy of Judah and Israel. By circumcising these Edomites and incorporating them into the nation of Judah, Hyrcanus opened the floodgates to subversion by these Edomites.

This subversion began with Antipater, the "advisor" of John Hyrcanus. As part of his subversive activities, Antipater also financed the Roman occupation of Judea, having bribed Julius Caesar for the favor of installing his son, Herod, as the governor of Galilee. The Judahite historian, Josephus, records all of this treachery in his books, The Antiquities of Judah and The Wars of Judah. Scholars have been duped into believing that the works of Josephus are the works of the "Jews." But Josephus clearly distinguishes between the true Judahites versus the invading Edomites. Once the reader is aware that an impersonation is going on, the text becomes immediately clear. Josephus has documented all of the treachery of the Edomites against True Judah. This is the main theme of the "Antiquities," especially

regarding the activities of Antipater, Herod, and the brief Herodian dynasty which lasted until 70 AD. It was the Edomite Herodians, in partnership with the largely Edomite sect of the Pharisees, who executed Christ.

As Josephus records, after Herod assassinated the last true Judahite King of Judah, Hyrcanus II, he assassinated the entire Sanhedrin and replaced them with his Edomite cronies. This "reconstituted" Sanhedrin, which contained a smattering of Judahites, such as Nicodemus and Joseph of Arimathea, was, in fact, an alien outfit, created by Herod to impose Herod's pagan religion upon the people of Judah. These historical facts provide an entirely different perspective on the events of the four Gospels. This explains why Herod and the Pharisees were so hostile to Jesus. They were NOT His kinsmen. "Ye are not My sheep," Jesus told them. They were usurpers who fully understood that Yahshua was the true claimant to the throne of Judah. Yahshua exposed their treachery at every turn, but modern Judeo-Christian scholarship simply ignores the historical record in favor of the "gospel of personal salvation," or "the gospel of prosperity," while eschewing the historical significance of the four Gospels.

Once all of these facts are known, it becomes abundantly clear that the religion of Judaism is an Edomite religion masquerading as Israelite religion. And the Jewish people are non-Israelites masquerading as Israel. The Bible itself predicted that all of this would happen. For proof of this, please see my essay, "The Marks of Israel," which documents the prophesied and fulfilled exploits of the children of Israel, who are today's Caucasian Race.

The Edomites of the Bible are the Jews of today. By their own admission: "Edom is in modern Jewry." – Jewish Encyclopedia, 1905 edition.

#### **Judeo-Christianity**

"An appalling and horrible thing has happened in the land: the prophets prophesy falsely, and the priests rule at their discretion; MY PEOPLE LOVE TO HAVE IT SO. But what will ye do when the end comes?" – Jer. 5:30-31.

The Apostle Paul, at II Thes. 2, declared that, just before the Second Coming, Christian Israel would abandon the true Faith. The KJV describes it as a "falling away." Astute theologians call it the Great Apostasy. Because Judeo-Christianity ignores its historical and racial roots, modern "Christianity" has abandoned the precious chosenness of True Israel. Hence, like Judaism, Judeo-Christianity is also based on two enormous lies: 1.) that the Covenants made exclusively with Israel were transmitted to "believers" or to some "church" organization, and 2.) the promises made to True Israel can be extrapolated to all non-Israelite peoples. This miracle is somehow accomplished by simply "accepting the Lord into your heart." The fact is that the Bible denies both of these propositions, as this essay will prove with abundant evidence.

The universalization of the Bible began with the Catholic Church. The word 'catholic' means "universal." But the Bible nowhere authorizes such universalization. The reformers of the Protestant Reformation realized that the Catholic Church was riddled with false doctrine. That is why Luther and others referred to Catholicism as "Popery" and condemned the Catholic Church as the "anti-Christ" of their time. Unfortunately, the Reformation has been likewise subverted by universalistic doctrine, to such an alarming extent that Protestantism is today more catholic than the Pope. This is the Great Apostasy foreseen by Paul. (II Thes. 2.) It is also the "false prophet" of Revelation.

Completely lost, whether ignored or deliberately obfuscated, in modern "Judeo-Christianity" is the eternal Covenant relationship that Yahweh God has established with True Israel. The Bible is absolutely clear about this Covenant relationship. It will exist forever and it cannot be revoked. Paul affirms this at Gal. 3:17. "And this I say, that the COVENANT, that was confirmed before God in Christ, the law, which was four hundred and thirty years after, cannot disannul, that it should make the promise

of none effect." Paul is simply stating that the Mosaic Law had nothing to do with the unbreakable Covenant relationship that Yahweh had established exclusively with the descendants of Abraham, Isaac and Jacob. Law or no Law, the promises and covenants cannot be annulled. Paul is asserting the exact opposite of what the Judeo-Christians have falsely assumed, namely that Paul is supposedly asserting that the law has been "done away with." A full analysis of what Paul is really saying in Chapter 3 of the book of Galatians will be presented later.

Before that can be done, the reader must fully understand the eternal and exclusive nature of the Covenants, promises and inheritance of the Old Testament, none of which can be transferred to any other people, and none of which have ever been abolished. The fact is that Paul confirms the racial covenants. He never denies them.

#### Part 1: The Exclusive, Racial Covenants of the Old Testament

The numerous distortions of biblical passages will now be revealed as being a combination of Jewish perversions of the Torah, plus Judeo-Christian distortions of the Gospel. Jesus said, "All things will be revealed." Yahweh said "I will choose your delusions." He has allowed True Israel to fall into a state of amnesia, precisely because we have refused to obey His laws. Hence, we have fallen into a stupor of denial, just as a drunkard collapses into the gutter, so drunk that he no longer knows who he is. Yahweh does not intend to allow True Israel to be kept in the dark forever. The Scriptures clearly state that Israel will awaken out of his delusion just before the Second Coming, so that we will realize the magnitude of our sin and repent before the return of our Lord and Savior, Jesus Christ.

The very first thing that must be realized is that the Hebrew word, *AWDAWM*, means "to show blood in the face." This literally means "to be able to blush." Only the White Adamic race has ever had this ability. Hence, Gen. 1:26-27 is declaring that only the White Race was made in the image of Elohim. The other races were already created at Gen. 1:24-25, as the "beast of the earth." This includes the Orientals, the Blacks, the Amerindians and all non-Whites. As will be shown, the Covenants were continuously narrowed down to an ever smaller group of people, from the Adamites down to Noah's eight souls. From Noah, the Covenants were transmitted, exclusively, through Abraham, Isaac and Jacob (Israel). Only the direct descendants of this genealogy were ever made a party to these promises and covenants. Note that a Covenant is a legal contract, which cannot be disannulled, just as Paul says. Yahweh has sworn by His own Name that these Covenants will never be altered or abolished. Jonah 3:8 describes the fact that Nineveh had both "beasts" (non-Whites) and "men" (White Adamites), both of whom were dressed in sackcloth and repented of their sins. There is no such thing as a four-legged "beast" capable of repenting. Only two-legged non-Whites can perform what is required here.

Gen. 1:28-30 declares the Dominion Mandate, which is given exclusively to the Adamic Race and to no one else. History proves that the White Race has always been the Dominion Race, exactly as Yahweh had intended. Likewise, our current decline was prophesied. Fortunately, our eventual reemergence as God's Chosen People was also prophesied; and nothing can stop this prophecy from being fulfilled.

It must be understood that Adam and Eve were NOT the first members of the White Race. Gen. 1:26-27 is declaring the CREATION OF THE RACE: "Male and female He created them." First the race was created. This is confirmed by Jesus Himself at Matt. 19:4. ("Male and female FROM THE BEGINNING.") Then, AFTER THE DAY OF REST, in Gen. 2, Yahweh selected two individuals of the White Race and breathed the breath of life into them. All of the races were created in Gen. 1, "kind after kind," bearing their own DNA, each kind carrying its own type of seed within itself (Gen. 1:11-12). As all scientists know, each species has its own seed, which is designed to replicate itself. This is the way Yahweh designed it; and that's the way it has always been. Nor will this ever change. The science of

genetics utterly refutes the fable of evolutionism, which is a totally unscientific speculation about the origin of species.

Genesis 2 introduces the single man, Adam, and the individual woman, Eve. It is upon these two individual specimens of the already existing Adamic Race upon whom Yahweh graciously bestows potential physically immortality, so long as they obey His commandments. He specifically tells them that they are NOT to even touch the "trees" of the other races. Throughout Scripture, trees are metaphors for peoples and races. Therefore, the "tree of the knowledge of good and evil" is that particular group, living in the Garden of Eden, in which both good and evil exist. This cannot possibly be a literal tree, for no wooden trees have knowledge of good or evil. The plant species do not have such capacity. Only humanoids have such knowledge, so this commandment is a prohibition to Adam and Eve against mixing with any species that has knowledge of good and evil. This includes the already existing Adamic race, which was and is still mortal. Adam and Eve were specially selected to be immortal; but sin and immortality do not mix. This is why Yahweh told Adam and Eve, "Do not touch the 'tree' that knows good and evil." Their offspring were not supposed to know evil.

Satan perfectly understood that the creation of an immortal seedline would overthrow his rebellion (Rev. 12). Hence, he understood that the only way he could thwart Yahweh's Plan to overthrow this rebellion was to adulterate Eve's offspring, by seducing her. That is exactly what Gen. 3 is about. All of the punishments that were inflicted upon Adam and Eve in that chapter are sexual in nature, from covering their sexual organs with loincloths to Eve's conception being cursed with exceptional pain. The resultant offspring of this seduction was Cain, while Abel was actually the son of Adam. Eve had a dual pregnancy (superfecundation) by two different males. Although super-fecundation was rare among the Israelites, it is very common today, as more and more women have become promiscuous, sharing their beds with different men on different nights, and sometimes with men of different races. In this way, a woman can be pregnant by two different men at the same time.

Gen. 4:1 records Eve's surprise at Cain's appearance, where she says, "I have gotten a man (IYSH, not AWDAWM) from Yahweh." The meaning of the Hebrew word IYSH is "a male of any species." Moreover, the root word from which IYSH derives is ENOSH, meaning "mortal." Eve was twice surprised: by Cain's appearance and by the fact that she perceived he was a mortal. Given Yahweh's promise that Adam and Eve would be immortal if they refrained from sin, Eve was very surprised that she would have produced a non-Adamic, mortal offspring, such as Cain. The fact that Cain killed Abel is proof that there was something seriously wrong with Cain.

We two-seedliners understand why: Adam was not Cain's father. Nachash, the "serpent," was Cain's father. The "Serpent" having thus polluted Eve's womb, Abel was also born a mortal; and Eve could no longer produce immortal offspring. She never got the chance, because Nachash impregnated her about the same time that Adam did. This is the true meaning of the FALL of Adam and Eve. Rather than ask Yahweh for a replacement, Adam chose to do what Eve did. He fraternized with the other races and apparently bore hybrid offspring as well. He should have asked Yahweh for a replacement for Eve; but this idea never occurred to him. Either that, or he loved Eve so much that he could not bear to lose her. Another possibility is that neither one of them were able to comprehend the consequences of their sin.

Gen. 5:1 records Adam's satisfaction with Seth, Abel's replacement, because Seth was born in Adam's own image, just as the Adamic race was conceived in the image of Elohim. Since Cain was not Adam's son, Cain was never even considered as part of Adam's genealogy. Even the New Testament genealogy leaves Cain out. Had Cain been the elder son of Adam, he would have had the rights of the elder son over Seth. But since he was not Adam's son, Cain had no such claim. (This theme will be repeated later, when Esau, the elder, despises his birthright, transferring it to Jacob-Israel, the younger.)

Although our species lost its potential immortality and fell into sinfulness, <u>we did not lose our race-specific DNA</u>. The law of kind after kind still applies, even though we fell back into mortality. <u>We</u>

<u>should not compound our sin by adulterating our seed ever again</u>. And the Bible repeatedly commands us to avoid this sin, even though the Jews, in their subversiveness, and the Judeos, in their apostasy, constantly advise us to do the opposite.

Given this understanding of what really happened in the Garden, we can now proceed to relate the story of Yahweh's Chosen People, Adamic Israel, and how we are commanded to remain separate and distinct from all other peoples. (NOTE: Paul's admonition to avoid controversies about genealogies does not apply to biblical geneaologies, as he was criticizing the Adamic Greeks (who were dispersed Israelites) about THEIR false genealogies, which asserted descent from fictitious gods. The Israelites of the dispersion had become so paganized and Hellenized that they no longer practiced circumcision and they had adopted many Greek customs, such as claiming descent from the gods and goddesses of the Greek pantheon. Those genealogies have nothing to do with OUR genealogy. This will be proven later in our discussion of the pertinent New Testament pericopes.) The fact the New Testament opens with the very detailed genealogy of Jesus Christ cannot be downplayed or ignored. His genetics cannot be ignored or criticized. Without these genetics, Yahshua could not have fulfilled His role as our Kinsman Redeemer. Also, without these genetics, we Israelites cannot achieve our destiny, which is to have restored to us the dominion and immortality which was lost by the sins of Adam and Eve.

#### The Racial Exclusivity of the Bible Documented: The Abrahamic Covenants

The reader is encouraged to go to all of the verses cited, to see the undeniably exclusive nature of the language.

The Bible faithfully records the genealogies of two distinct groups: the descendants of Cain and the descendants of Adam. Gen. 4:11-24 records the genealogy of the Kenites, the descendants of Cain. These Kenites are, very clearly, a non-Adamic people.

Gen. 4:25 – Gen. 5:25 records the genealogy of the Sethites, the descendants of Adam and Eve through Seth. The Bible is the historical record of the conflicts, wars and enmity between these two groups of people; but both Judaism and Judeo-Christianity have whitewashed and obfuscated this history. The Bible is the story of the separate and distinct genealogies of these two seedlines and how the conflict of the ages, the racial war between the Adamites and the Kenites, will be resolved at the battle of Armageddon, when Jesus returns with His mighty angels to vanquish the Edomites, the people of God's curse. Throughout Scripture, Israel's most vicious enemies always derive from the seedline of Cain. This singular, indisputable fact is totally ignored by the Jewish perversion and the Judeo-Christian distortion of the Bible.

Gen. 6:1-4; 7-12. The Flood was NOT global. The Kenites most certainly survived the Flood. [Good web article debunking the global flood myth: <a href="http://ecclesia.org/truth/flood.html">http://ecclesia.org/truth/flood.html</a>] Gen. 9:8-11. The Noahic Covenant is established with Noah and his direct descendants, "with you and your seed," exclusively. The other races of the world, which had already existed for thousands of years in their specific habitats, are not a party to this covenant. The idea that all species stem from the few that were on the Ark is pure mythology. The Bible says no such thing. It is an idea that is a holdover from the flat earth society that prevailed during the translation of the KJV. The Rainbow Covenant of Verse 13 is the only one made with the entire earth. This is not an exclusive covenant. All of the other covenants are made exclusively to, for and with the specific posterity of Jesus Christ's genealogy. These people are today known as Caucasian Israel.

With regard to Yahweh's punishment of the Adamites in Noah's time, Michael A. Clark has this to say:

"Prior to the Great Deluge of the Patriarch Noah's day, the whole <u>known world</u> was in an uproar to the extent that the survival of the people that God had brought forth to serve Him in righteousness was being

put in jeopardy. What was taking place was far more than a spiritual or religious threat to the cultural integrity of the People of God. It was a threat to disrupt the genetic destiny of their families for all time. Almighty God looked upon world society and saw that 'all flesh had been corrupted.' Miscegenation, or the interbreeding of racial types, was taking place on a scale and in a way that the Almighty had to intervene by a direct act of global judgment. In all this, it should be noted, Noah was 'perfect in his generations,' or in his family of marriage unions." - "Coming Events Cast Their Shadow," p. 268, Crown and Commonwealth, Winter 2006.

Gen. 12:1-3 declares the exclusive Covenants made with Abraham and his direct descendants (posterity). No other group, outside of this specific genealogy can be included in these covenants. Note that Abraham was not a Jew, so these Covenants do not apply to the Jews. Since Ishmael was the father of the so-called Arabs, these people are also descendants of the Abrahamic Shemites. Thus, the Arabs have just as much claim to Semitic heritage as the Jews do. In both cases, however, there is very little Adamic genetic material in the modern Arabs and Jews. Both Jews and Arabs are very miscegenated people. Verse 3 specifically states that all nations, which are not a part of this specific posterity, will be blessed or cursed depending upon whether they bless or curse us, the true posterity of Abraham. Note that the word 'Jew' is not used in this passage, nor does this passage apply to Jews, since they are the descendants of Cain and Esau, who are NOT of the posterity of Abraham, Isaac and Jacob. Despite Jewish claims to the identity of Israel, the covenants do not apply to them, because they are not Israelites, Hebrews, Shemites, or Judahites. Nor are they the TOLEDAW (descendants) of Adam. They have always belonged to the genealogy of Cain. (Matt. 23:33-36.)

Gen. 13:14-17: Abraham's direct descendants will be an immense multitude. Caucasian Israel has fulfilled this promise. The Jews have not. The Jews have always been a minority on the world's stage. This minority status is a fulfillment of a specific prophecy of Esau, whose numbers will be small. (Obadiah 2, 3.)

Gen. 15:18-21: declares how Abraham's descendants will displace the sons of Cain, but only in the land of Canaan. Yahweh's intention in the land of Canaan is very specific: to exterminate the hybridized offspring of the fallen angels, who cohabited with the daughters of Adamkind in Gen. 6. In the days of the Israelites, these giants and other forbidden hybrid creatures were still walking the earth in the land of Canaan.

Gen. 16: There is a common misconception that, because Hagar was an Egyptian woman, that she was non-White. This is a false idea. Since Yahweh specified that only race-specific animals were allowed aboard the Ark, no hybrids were allowed. Noah's three sons, Shem, Ham and Japheth were as white as Noah and his wife, Naamah.

Gen. 17:1-14: The Covenant is renewed between Abraham and his direct descendants, exclusively (Verse 7) in their racial descent (*toledaw*), for an everlasting covenant. The many nations prophesied here are the White nations of Europe, America, South Africa, Canada, Australia, etc., which were founded by the direct descendants of Abraham, Caucasian Israel. The word 'stranger,' in verse 12, is anyone not of ABRAHAM'S DIRECT LINEAGE. Such people can be made slaves. Israelites cannot be made slaves, except for those who willingly sell themselves into indentured servitude in order to pay off their debts. But even these are to be set free every seventh year. In addition, all debts are to be cancelled and the property of the Israelites is to be returned to them every 49<sup>th</sup> year, the Year of Jubilee. Although slavery will eventually be abolished ("Israel will set the slaves free."), the time is not yet. Even though people of other nations can be the servants of True Israel, this does not give Israelites the right to mistreat them. The Covenant Nations of Caucasian Israel had to be established before any slaves could be set free. As per the promise of Gen. 12:3, the Anglo-Saxons have been a blessing to the world, providing agriculture, science, medicine, high art, music, hygiene, roads, railroads and all manner of spiritual and physical blessings to the world wherever we have gone. All of these blessings are the direct fulfillment of the blessings provided to Abraham's direct posterity.

#### The Covenants Renewed and Continued with the Exclusive Descendants of Isaac.

Gen. 17:15-22: Verse 19 continues the Covenant with Isaac, who is the direct descendant of Abraham through Sarah, <u>but Ishmael is excluded from the Covenant</u>, because Ishmael's mother is Hagar, not Sarah. Instead, Ishmael is given a blessing (Verse 20).

Gen. 18: 9-15: The circumstances of Sarah's conception by Abraham.

Gen. 21:1-14: Sarah demands that Hagar and her son, Ishmael, be cast out of her presence, so that Ishmael could not interfere with Isaac's inheritance. The Book of Jasher provides additional details about Sarah's displeasure with Ishmael. Jash. XXI:14-15 tell us that Sarah witnessed Ishmael drawing his bow, with intent to kill Isaac. This made her fear for Isaac's life. She therefore demanded that Abraham send Ishmael and his mother away.

Gen. 21:12: "In Isaac shall thy posterity be called." The future Anglo-Saxon nation is here prophesied. Verse 13: Ishmael blessed, "because he is thy seed," but not covenanted.

Gen. 22:1-19: Isaac is dedicated to Yahweh on the altar. All of Isaac's direct descendants are thus a party to Isaac's chosenness. Question for the universalists: If Ishmael is excluded from the Covenant by Yahweh Himself, why are you trying to bring them back in with your "spiritual Israel" doctrine? In arguing for the equality of all "in Christ Jesus," you are violating the terms of the Covenants. You have no right to do this!

Gen. 24:62–67: Abraham is very insistent that Isaac's wife-to-be must be of a particular race. She must be a Shemite of the house of Aram. Aram was the fifth and youngest son of Shem (Gen. 10:22). The Shemites are White, as even the universalists agree! This chapter is very racially exclusive. Verse 61: Yahweh chooses Rebecca (Rebekah), arguably the most racially exclusive woman in the Bible, to be Isaac's wife.

Moana Finch, commenting on Abraham's selection of a Pure White wife for Isaac, says, "So the race would be kept pure and of the one type of blood, a wife was chosen for Isaac of the family of Nahor. It was to Rebekah, Isaac's wife, that the Gate of Israel's enemies was promised. Genesis 24:60. Strictly speaking, Isaac cannot be termed an Israelite, for they were a later generation. Isaac was the FIRST SAXON, and being a descendant of Abraham, a Hebrew. He can also be called a Semite or Shemite, as he was descended from Shem." – p. 22, Thy Kingdom Come, December 2002.

[Strictly speaking, Abraham was not a Jew, for the same reason. Nor was Isaac. Nor was Jacob. Even Judah was not a Jew. He was the first Judahite. All of these men — and their wives - were of pure Adamic descent, without any admixture of non-Adamic blood. The Jews, contrariwise, are the most miscegenated breed on the face of the earth.]

Gen. 25:1-6: Abraham marries Keturah after Sarah dies. She bears him six sons, but Isaac was the exclusive son of the Covenant (verse 5). He sends Keturah's sons away to the east, so that they cannot interfere with Isaac's inheritance (Verse 6). These sons of Keturah became known as the Indo-Aryans, as many of them travelled as far as India, setting up Brahmanic (Abrahamic) culture there. The exclusivity of the Covenant is drastically illustrated by how frequently family members are EXCLUDED from the inheritance. Yahweh is consciously excluding those He knows are not qualified – even those of the same race! - for the promises made to the specific seedline.

#### The Story of Esau and Jacob.

Gen. 25:19: Isaac marries Rebecca. Rebecca conceives twins, but one of them will be a traitor to the genealogical seedline. "Two nations are in thy womb."

Gen. 25:33-34: Esau sells his birthright to Jacob. Esau despises his birthright. Thus, Jacob becomes the elder son.

Gen. 26:33-35: The Hittite (Canaanite) wives of Esau condemned.

Gen. 27:41: Esau hates Jacob because He blames Jacob for stealing his blessing. He intends to slay Jacob as well. Esau is a greedy, nasty person. It is no wonder that Yahweh Himself hates Esau. "Esau I have hated. Jacob I have loved."

Gen. 27:46-28:1: Isaac and Rebekah make Jacob swear not to marry outside of their race.

Gen. 28:13-15: The Covenant Seedline promised to Jacob.

Gen. 35:9-12: The Covenant promises repeated.

Gen. 36: The descendants of Esau/Edom. This is a completely separate genealogy from that of Jacob/Israel.

Gen. 49: The prophecies of the 12 sons. None of these prophecies have ever been fulfilled by the Edomite or Khazar Jews. All have been fulfilled exclusively by the Anglo-Saxon nations.

#### More Proof of Yahweh's Laws Against Miscegenation

Gen. 38: Judah and Tamar. The story of Judah and Tamar proves that half-breeds cannot inherit the Kingdom of Israel. Even though Shelah was the older half-brother of Zarah and Pharez, Shelah never even gets consideration as the eldest son - for the same reason that Cain did not get eldest son consideration, because both Cain and Shelah were half-breeds. Only pure-blooded Israelites, descended from the father, get consideration for inheritance. This episode also proves that "adultery" has nothing to do with marriage. This is another modern interpolation of Scripture. Even though Judah was married to the Canaanite woman (against Yahweh's law), their surviving son was not even considered as a patriarch of Judah. Tamar's eldest son, Pharez, was given this honor. Because both Pharez and Zarah were both pure-blooded Adamites (Tamar was a descendant of Shem), only they could get consideration as patriarchs of Israel. Even though Tamar "played the harlot" and never married Judah, only Pharez and Zarah could inherit the Adamic bloodline. This parable clearly tells us that Yahweh is more concerned about bloodlines than marital status.

Deut. 7: This entire chapter concerns the law that Israel must remain separate from all Canaanites. "Thou shalt make no covenant with them nor show mercy to them. Neither shalt thou make marriages with them." Any Israelite who marries a Jew (Canaanite, Edomite or Khazar) is violating Deut. 7. Furthermore, if we Israelites remain separate from the Edomites and Canaanites, we will have his love, blessings, bounty, good health, good children. "Thou shalt be blessed above all people." All we have to do is stay away from Jews. Whenever we allow Jews to flourish in our nations, we suffer the degradations of second-class citizens, as the Jews are masters of subversion and usurpation. No lamb can live among wolves.

Deut. 9: The wickedness of the Canaanites is stressed. They are so wicked that Yahweh wants them destroyed. But soft-hearted Israel fails to appreciate the threat of the offspring of the fallen angels. The Anakim (descendants of the Nephilim) are still in the land of Canaan, since the flood of Noah; and the rest of the evil Canaanites flourish there. Yahweh is using the Israelites to judge the Canaanites.

Exo. 23:31-33: The Philistines excluded from association with True Israel.

Deut 17. Evildoers are to be punished, not coddled. Those who are worthy of death must be executed. "So shalt thou put the evil away from among you." Nowhere in Scripture does it say, "Love the sinner, hate the sin." That's Judeo-Christian hogwash. Yahweh hates sinners. He does not even hear the prayer of a sinner. (John 9:31.) Verse 14 and 15 tell us how to choose a king from amongst ourselves. We are not to choose anyone who is not of our race!! "One from among thy brethren shalt thou set king over thee: thou mayest not set a stranger over thee, which is not thy brother (kinsman)." Can you imagine how upset Yahweh is with those silly Whites who voted for Obama?

Deut. 23:2-3. A mongrel [Heb. 'mamzer'] shall not enter into the congregation of Yahweh; even to his tenth generation shall he not enter into the congregation of Yahweh. An Ammonite or Moabite shall not enter into the congregation of Yahweh; even to their tenth generation shall they not enter into the congregation of Yahweh forever.

Strong's Concordance provides us with a very simple definition of *mamzer*: "mongrel." This word has nothing to do with marriage. It is a prohibition against race-mixing. These passages are totally consistent with the story of Judah and Tamar. Even though Judah had a "legitimate" child by marriage with the Canaanite woman, Shelah was never considered to have the right of inheritance. Only Pharez and Zarah ahd that right, even though they were born out of wedlock, because they were pureblooded Shemites.

What was the sin of Solomon, that caused Yahweh to condemn him in his old age?

"But King Solomon LOVED MANY STRANGE WOMEN, together with the daughter of Pharoah, women of the Moabites, Ammonites, Edomites, Zidonians, and Hittites: of the nations concerning which Yahweh said unto the children of Israel, YE SHALL NOT GO INTO THEM, NEITHER SHALL THEY COME IN UNTO YOU. — I Kings, 11:1-2.

Can it be any clearer what Solomon's sin was?

Ezra 4: The Judahites, observing Yahweh's laws of separation, reject the company of the Samaritans. Today, this is called "discrimination" or "racism."

Ezra 9: Ezra is astounded at the loose morals of those Judahites who have taken foreign wives. The sin of race-mixing is thoroughly condemned.

Neh. 10:28; 13:23. Ditto.

Psalm 106:34-45. Because the Israelites did not destroy the Canaanite nations, Yahweh punished them by handing the Israelites over to the heathen for punishment. "But they mingled with the nations, so…He gave them into the hand of the heathen." This happens whenever we Israelites mingle with non-Whites. Yahweh uses those nations with whom we race-mix to punish us. This clearly is happening to the White Race today. The only way to end this form of Divine Punishment is to eject these non-Whites from our nations, as Abraham Lincoln and the Whigs were doing.

Book of Obadiah. Obadiah declares the ultimate destruction of the Edomites. From all of the above, It is very obvious that we Israelites are forbidden to intermarry with Edomites, Ishamaelites, Canaanites, Philistines, Ammonites, Moabites, Zidonians, Hittites, and many other peoples. What do these nations have in common?? They are either non-White or half-breed nations. And this exclusivity is upheld in the New Testament, by none other than Paul. If all of these peoples are declared to be outside of the pale, who makes you think that other races, such as Blacks, Amerinidians and Orientals can be brought in? Who is it that has been lying to you about miscengenation?

The above list is only a small sampling of the separatist verses of Scripture. All of the major prophets, from David to Jeremiah to Ezekiel and Daniel, to all of the minor prophets, condemn the Edomites (Deut. 23:7 is a mistranslation, which is totally contrary to all other Scriptures about the Edomites, as Paul confirms. The correct word there is 'Aramites'. There is very little difference between the Hebrew d and r. It's like the difference between a jot and a tittle. There is little doubt that this is a copyist's error.) The Jews always use sex and money to get us to associate with them. Satan knows our weaknesses as well as Yahweh. Do you recall when Jesus fashioned a whip and drove the moneychangers out of the Temple? They were Edomites and Canaanites. The Jews always set up moneychanging operations wherever they go. No Levitical priest ever set up an exchange in the House of the Lord. Only Jews do that sort of thing.

This separatist language has been deliberately obscured, denied, changed, interpolated, ignored and otherwise destroyed by both the Jews and the Judeo-Christian churches of apostasy.

The Word Study Method proves that the Israelites of the Bible are exclusively White and that they MUST SEGREGATE THEMSELVES FROM ALL OTHER PEOPLE.

#### **AWDAWM**

It must be understood that the Hebrew word, 'Awdawm,' means, "to show blood in the face." Strong's #119: 'adam (pronounced aw-dam') to show blood (in the face), i.e. flush or turn rosy:--be (dyed, made) red (ruddy). - Bible tools.org

#119 adam (awdawm) – to show blood (in the face), i.e. flush or turn rosy:- be (dyed made) red, (ruddy).

#120 adam (awdawm) – from "adam" (119); ruddy, i.e. a human being (an individual of the species, mankind, etc.): -- X another, + hypocrite, + common sort, X low, man (mean, of low degree), person.

#121 Adam (awdawm) – the same as "adam" (120); Adam, the name of the first man, also of a place in Palestine:--Adam.

The Bible distorters always give false definitions of this word. The usual false definition is that it means "mankind," in the sense of all biped races. Or they say that it means "red earth." But dirt doesn't turn rosy, neither do the other races. Only the White Race shows blood in the face. The other races are referred to by their national names in Scripture.

When the Bible speaks of "Adam" as either individuals or collectively, it means White people only.

The Bible is written to, by, for and about the descendants of Adam and Eve, exclusively. It is a moral instruction manual for the Adamic species. It is only from this species that the Chosen People can come.

#### **TOLEDAW**

Gen. 6:9. The King James Version reads as follows: "These are the generations of Noah: Noah was a just man, perfect in his generations." In Gen. 6:9, where Noah is described as being "perfect in his generations," the word 'generations' comes from the Hebrew toledaw, which means "descent." There is only one possible meaning here: Noah was pure in his genealogy, his RACIAL DESCENT from Adam.

Gen. 5:1 "This is the book of the generations (toledaw, family tree, descendants of) Adam. In the day that God created Adamkind, in the likeness of God (elohim) made He him."

DNA is like a computer program. Any geneticist will tell you that mutations invariably cause disease and death. DNA is exclusive to every species. DNA replicates its own kind and none other. Wheat seed produces wheat. Corn seed produces corn. Adamic seed produces more Adamites. Negro seed produces more Negroes. Oriental seed produces more Orientals. That's how it works. Every scientist knows this. Only when somebody messes with the genetic programming is there a different result.

#### Racial Evidence of Noah's Flood

Gen. 6:2. "The sons of God (ben elohim) saw the daughters of men (Adam) that they were fair (white-skinned); and they took them wives..."

Gen. 6:9. "These are the generations of Noah: Noah was a just man and perfect in his generations." Purely Adamic in his descent. Toledaw means descent, genealogy, offspring.

Noah's Flood was NOT global. The deluge (rainfall) was global, but the Flood of Noah was local. Surely, there was flooding elsewhere, but the bible is not concerned with elsewhere. It is concerned with the direct offspring of Adam and Eve. (Gen. 5:1.) The Hebrew word, erets, means "Land, country, territory."

Only rarely does it refer to the entire planet. The context must be carefully considered when choosing a global definition.

The Book of Jasher states that the sin committed by the Adamites was race-mixing (Jasher 4:18), that Noah chose three pure-blooded daughters of Methuselah as wives for his perfect sons (Jash. 4:35), and that some of the Nephilim escaped the Flood (Jash. 5:25). Josephus reports that belief in a global flood was by no means unanimous in his day. He quotes Berosus, a descendant of Arphaxad, and others, which argue that Noah's flood was local in character. Josephus quotes Nicolaus of Damascus as saying, *There is a great mountain in Armenia, over Minya, called Baris, upon which it is reported that many who fled at the time of the Deluge were saved; and that one who was carried in an ark came on shore on top of it; and that the remains of the timber were a great while preserved.*"

So, "many fled" but Noah was preserved in an ark. This is exactly what Jasher reports. Incidentally, Ma-Nu in the Rig Veda is obviously the "Man-Noah" and Utnapishtim is the Ut-Noah-Pishtim of the Epic of Gilgamesh. This Epic was written by Gilgamesh. It is the record of Gilgamesh's visit to Noah after the Deluge. It is an interview of Noah by Gilgamesh. As many theologians are archeologists have stated, most of the world's civilizations survived unscathed by Noah's Flood. The civilization of Egypt was not even affected by it, as the dynasties before and after the Flood (circa 2345 BC) show no sign of interruption.

Here is how Bertrand Comparet assessed the situation:

Among the many mistaken and unScriptural notions commonly taught in nearly all churches is the idea that the "flood", mentioned in the Bible, covered all the earth and drowned everybody on earth excepting only Noah and his family who escaped death by being in the Ark. Some churches have firmly insisted that the Bible says this, when there is ample proof that the "flood" was not world wide. With this teaching the churches have destroyed the faith of multitudes of people in the Bible. They have made atheists or agnostics out of hundreds of thousands of people who might have become Christians if they had only been taught the truth about the Bible.

Part of this mistaken idea about the "flood" is due to the many mistranslations found in the commonly used King James version of the Bible. Also, part of it appears plainly to be false if you merely carefully read even the King James version. Let's have a look at it.

In Genesis chapter 6, we read that God found the people so corrupt that He regretted that He had ever created them, so He decided to wipe them out by a flood. He warned righteous Noah of the coming flood and told Noah to build a great boat, or ark, in which he and his family might find safety and where they might preserve a few of each kind of the animals from that area. In Chapter 7, it tells how Noah received the final warning that the time was now at hand and he should move into the art. Then it says, according to the King James version, "And it came to pass after seven days, that the waters of the flood were upon the earth.

Now, first let us see what the translators have done to what Moses originally wrote. You remember that the King James version says that the rain was upon "the earth" and the waters increased greatly upon "the earth": and that "all flesh died that moved upon the earth"?

Remember that in Genesis 4:14, when God has driven Cain away in punishment for his murder of Abel, the King James version quotes Cain as saying, "Behold, Thou hast driven me out this day from the face of the earth." So what did Cain do, climb into his rocket ship and take off for outer space? Of course not!! He was not driven from the face of "the earth", and he never said so, only the translators said so.

The word Cain used was "ad-aw-maw" meaning "the ground": God had told him that his farming would no longer be successful, so Cain said "Thou hast driven me off of the ground." (You have probably noticed that Cain's descendants today are not farmers. They run pawnshops and other money lending institutions.)

When we come to Genesis 7, where it is talking about the "flood", wherever it says that the flood covered "the earth", the Hebrew word used in the original writing by Moses was "eh-rets", meaning "the land". The flood did cover the particular land where it occurred. That is, it was a local flood which covered one particular region or land, not the whole earth.

Again, notice that it specifies that "15 cubits upward did the waters prevail; and the mountains were covered." In ancient times two different lengths of the cubit were in use, the sacred cubit of 25 inches and the common cubit of 20-5/8 inches. Therefore, the waters rose above the tops of the mountains it is speaking of by either 25 feet 9 inches or 31 feet 3 inches according to which cubit you use. If this meant that all the mountains on earth were covered, the waters would have to cover Mount Everest, which is nearly six miles high, therefore, all the earth would be covered by water six miles deep. In that case, where could it have run off to when the flood subsided? No, I don't mean that the Bible was that badly mistaken, only the translators made this mistake. The translators took the Hebrew word "eh-rets" which means "that land" and mistranslated it to mean the whole world.

Therefore, the Bible is correct in stating that the Flood covered only "eh-rets", "that land". The translators are wrong when they change the meaning of what Moses really wrote in Genesis 7, and say that the flood covered all "the earth". — Bertrand Comparet, "Noah's Flood Was Not Worldwide."

Gen. 7:20: <u>Fifteen cubits</u>, and the mountains were covered. (Heb. *Har*, meaning a mountain or a range of hills.) The idea that all races suddenly sprang from Noah's three sons is both biblically and scientifically false. Those denominations who teach this are actually teaching a form of rapid evolution, for which there is no evidence in Scripture.

Gen. 7:14 specifies that Noah should only accept pure-blooded species into his ark. Why would Yahweh make such a specification if He wanted the descendants to be variegated offspring? That would make no sense at all! But myth and dogma do not need to make sense. Make-believe, passed off as theology, must be believed, however, despite the lack of evidence.

#### **BERITH (COVENANT)**

Definition of the term 'covenant'. Strong's Hebrew #1285, Berith (in the sense of cutting, cut a covenant, cut a deal) – a compact..confederacy, covenant, league. Strong's Greek #1242, diatheke, a disposition, contract, covenant, testament.

Dictionary Definition:

- 1. A binding and solemn agreement by two or more persons, parties, etc., to do or keep from doing some specified thing; a contract; compact.

Gen. 17:4: *As for me, behold, MY COVENANT is with thee, and thou shalt be a father of many NATIONS.*" It does not say ALL nations. Those "many" are, specifically, the Caucasian people and the specific nations we have founded.

Now, let's take a look at the verses immediately following verse 4:

"Neither shall thy name any more be called Abram, but thy name shall be Abraham: for a father of many nations have I made thee. And I will make thee exceedingly fruitful, and I will make nations of thee, and kings shall come out of thee. <u>And I will establish my covenant between me and thee and THY SEED AFTER THEE IN THEIR GENERATIONS</u> [which means only those direct descendants who are to come from the lineage AFTER HIM] <u>for an everlasting Covenant</u>." These verses guarantee that the

Covenants made with Abraham will apply to his POSTERITY, his direct descendants and to NO ONE ELSE... FOREVER. Make no mistake about it: The other races and even the other Adamic tribes were already in existence. Nevertheless, the Covenants made with Abraham concern only his posterity and no one else. That's how exclusive this Covenant is! Let's prove it.

Yahweh repeats this promise at verse 9: "And God said unto Abraham, <u>Thou shalt keep my covenant</u>, <u>therefore, thou, and thy SEED after thee in their generations</u>." No other nation has ever kept these covenants and no other nation has ever been a party to these covenants.

Gen. 17:19-21. Ishmael blessed, but only Isaac is covenanted.

And Abraham said unto God, O that Ishmael might live before thee! And God said, Sarah thy wife shall bear thee a son indeed; and thou shalt call his name Isaac: and I will establish my covenant with him for an everlasting covenant, and with his seed after him. And as for Ishmael, I have heard thee: Behold, I have blessed him, and will make him fruitful, and will multiply him exceedingly; twelve princes shall he beget, and I will make him a great nation. But my covenant will I establish with Isaac, which Sarah shall bear unto thee at this set time in the next year.

Gen. 28: 10-15. Covenant renewed with Jacob and his descendants.

From these verses, it is absolutely clear that we are talking exclusively about Abraham and his DIRECT DESCENDANTS, who came after him in pure genealogical fashion. All others are excluded and cannot partake of this Covenant relationship with Yahweh. It is based purely on direct descent. It is a bloodline, period. Only the direct posterity of Abraham, Isaac and Jacob are parties to these Covenants. To be sure, ALL OTHER PEOPLE ARE EXCLUDED FROM THIS COVENANT RELATIONSHIP. Now, at Verse 13, we are informed that this Covenant is an exclusively racial covenant:

"He that is born IN THY HOUSE, and he that is bought with thy money, must needs be circumcised: and my covenant shall BE <u>IN YOUR FLESH</u> (racial DNA) for an <u>everlasting</u> Covenant."

The Exclusive Covenants With Israel Confirmed by All of the Prophets

"You only have I known of all the families of the earth: therefore will I punish you for all your iniquities." - Amos 3:2. Peter confirms this language when he says, "Judgment must begin at the House of God," (I Peter 4:17) which can only be the whole House of Israel. All of Scripture confirms this. It is only because of the poor translations, deceptive definitions, Jewish "tradition," and Judeo-apostasy that anything different is taught today.

"Sing, O daughter of Zion; shout O Israel; be glad and rejoice with all the heart, O daughter of Jerusalem. Yahweh has taken away your judgments, He has cast out your enemy. The King of Israel, even Yahweh, is in the midst of you: you shall not see evil anymore." – Zeph. 3:14-15. This is the Gospel (Good News) being proclaimed in the Old Testament for the Israelites of the New Testament, those who have had their past sins forgiven by Messiah at the cross.. This good news is exclusively for Israel, although it will positively affect the residents of the whole world, once Adamic Israel is restored to dominion.

"And they shall be as though I HAD NOT CAST THEM OFF." - Zech. 10:6.

All of the OT prophets confirm the exclusive, unchangeable covenants with Adamic Israel. Anyone who says that these covenants were changed in the NT to include non-Israelites is a liar. This false doctrine is direct contradiction to all of Scripture. This false idea that True Israel has been abandoned by God and replaced by the Church is the central tenet of the doctrine called "Dispensationalism." Since dispensationalism contradicts every pronouncement of Covenant theology, they make Yahweh to be liar. Who do think is lying? Yahweh or the false priests?

#### Israel is Yahweh's Servant People

We are Yahweh's Servant People. Neither the Jews, nor any other people, have ever sereved Him. They have always served their own gods.

Isa. 4:21: "Remember these O Jacob and Israel; for thou art my servant: I have formed thee; thou art my servant: O Israel, THOU SHALT NOT BE FORGOTTEN OF ME."

Verse 22 is a prophecy of the coming of the Kinsman Redeemer of Israel: "I have blotted out, as a thick cloud, thy transgressions, and, as a cloud, thy sins: return unto me; for I have redeemed thee." These words were spoken only to Israel, and no one else. Acts 7:31 confirms that this forgiveness only applies to Israel.

Isa. 42:1 tells us this: "Behold MY SERVANT (Israel), whom I uphold; MINE ELECT, in whom my soul delighteth; I have put my spirit upon him: he shall bring forth judgment to the nations." Isaiah does NOT say that Israel will become the nations. He tells us that we will bring judgment TO the nations.

#### **PROMISE**

The Promises were made exclusively to Abraham, Isaac and Jacob...and their descendants.

Gen. 16:6-12. Hagar's son is Ishmael, the progenitor of today's Arabs.

Paul confirms Ishmael's exclusion in Gal. 4:22-31. We Anglo-Saxons are the children of the free woman, Sarah. The Ishmaelites (today's Arabs) are the children of the bondwoman, Hagar.

Gen. 17:1-16, 19-21. "Perfect" is *Tamiym*, without blemish, without spot. This is the same word that is used of all sacrificial animals. This word cannot be equated with good, upright, or blameless. This is a reference to genetic purity.

Yahweh's specific promise is given to Sarah (Gen. 17:15-16). She will be the mother of a bloodline. Her direct descendants will be kings and nations.

Again, Paul confirms the exclusivity of these promises. Gal. 3:13-19. This covenant cannot be disannulled. "Abraham's seed will be a blessing to all nations." Paul confirms the exact terms of Gen. 12:3 at Gal. 4:14. Nothing has been altered, nor can it be altered.

The whole of Chapter 3 is devoted to explaining that the forgiveness of Israel was not dependent upon the Law of Moses. It was promised independently of the Law, even BEFORE the Law, through Abraham. That's why the Law cannot annul this promise.

"Now to ABRAHAM AND HIS SEED [posterity] were the promises made. He said not "and to posterities [such as those genealogies which have been decidedly excluded from the promises], as of many [posterities]; but as of ONE [posterity], to your seed [posterity], which is anointed. — Gal. 3:16. The KJV translation of "which is Christ" is absurd, as the promises were NOT made to Jesus Christ. The verse begins by recounting the direct genealogy to which the promises were applied. These promises were made to all of Abraham's direct descendants, through Isaac and Jacob's descendants. The specific promise that the Messiah [Christ] would come to Israel is being affirmed here. Christ did not come to redeem Himself, as this horrible translation implies. Nor were the promises made to Him. He is the Redeemer who was promised to Israel. Gal. 3:16 is speaking of the ANOINTED PEOPLE, ISRAEL. "I come not but unto the exiled sheep of the House of Israel." — Matt. 15:24.

He did not come to redeem himself. He was sinless. These nonsensical translations in the KJV have made absolute mincemeat of the True Gospel.

Also, Gal. 3:28-29 is horribly translated. It should read, "There is neither Judean nor Greek, there is neither bond nor free, there is neither male nor female: for you [ISRAEL] are all one in Christ Jesus. [This confirms that the anointed people, Israel – all twelve tribes, including those of the

Dispersion, male or female, free or bond, Judahite or Hellenized Israelites – were redeemed at the Cross.] *And if you be anointed, then are you Abraham's seed* [direct posterity] *and heirs according to the PROMISE.*"

Paul is confirming that only the <u>anointed people</u>, those to whom the promises were made, are the recipients of the promise that was delivered. Sarah specifically disinherited Ishmael at Gen. 21:10. Esau disinherited his own descendants by selling his birthright, and Paul has no authority to change the terms of the covenants and promises. Nor does he claim to have such authority. He specifically states that no one has the authority to GIVE OUR INHERITANCE TO ANYONE ELSE; but the KJV and the Dispensationalists claim otherwise! This is GRAND THEFT, by mistranslation! But these promises can be fulfilled only by ensuring that they are delivered to their intended recipients. The KJV has butchered these verses so badly that they make no sense whatsoever. However, the universalists just love to preach nonsensical sermons about how ALL PEOPLE – even the Ishmaelites and Edomites who were specifically excluded - can become "Abraham's seed" by "having faith." Can you believe this? Believe it, because they have pulled off this tremendous scam by mistranslating a few words! Paul said no such thing.

Galatians 4:1-7 carries the radical word stretching further by falsely translating the Greek *huiothesia* as ADOPTION in verse 5. Strong's tells us that this word means the "PLACING, as a son." The word, ADOPTION, is added as an example, but it is a bad example, because only sons and daughters can be put into the place of INHERITANCE. Now, a son or daughter can be placed into the position of inheritance when they come of age. But, only those directly named in the LAST WILL AND TESTAMENT count as heirs. This is how the promises to Abraham, Isaac and Jacob have been fulfilled TO THE LETTER. Paul is saying that the heirs have "grown up" and now qualify for the inheritance. No other human beings can possibly qualify as heirs. In this verse, Paul first makes it clear that Christ came to redeem them that were under the law [of sacrifices], which had been delivered to and practiced exclusively by Israelites and no other people!!!! So, how can the people of other nations be adopted? These two concepts are in direct contradiction to each other.

Verse 6 confirms that he is talking about true sons, not those adopted from other nations.

Verse 7: "Wherefore you [the direct descedants of Abraham, Isaac and Jacob] are no longer a servant, but a son; and if a son, then an heir of God through Christ." Remember that only Israel was considered by Yahweh to His Servant People. We are to serve Him by bringing the world order back under His Law. As the City on the Hill, we are to set the example for other nations to follow. If we mix with them, we become like them. If we become like them, then there is no city on the hill.

As Paul stated twice already (Gal. 3:15, 17), these covenants CANNOT BE ANNULLED, but the translation committee of King James have done their utmost to rewrite history, deny that these covenants mean what they say, and declare that the promises have been annulled, by CHANGING THE TERMS OF THE PROMISES AND COVENANTS and adding the rest of creation to the redemption. This doctrine is in total violation of the terms of the covenants, promises, and inheritance. But false priests have no problems with contradictions.

Arnold Kennedy has done the best analysis of the KJV's poor translation of the book of Galatians. His article, "The book of Galatians and an Israel Exclusive" is must reading. First, a quotation regarding Gal 3:26 and 3:29:

In these two critical verses we have something else [not Jesus Christ] which is anointed! What can it be? What is the subject? Is it not the seed of Abraham, in their generations, according to the original promise? Hence, Gal. 3:16 reads 'and TO THY SEED which is anointed' and Gal. 3:29 reads 'and if ye be an anointed (people) then ye are Abraham's seed. The churches try to spiritualize the matter of Abraham's seed." - Source: <a href="http://www.israelect.com/reference/ArnoldKennedy/The%20Book%20of%20Galatians%20&%20an%20Israel%20Exclusive.pdf">http://www.israelect.com/reference/ArnoldKennedy/The%20Book%20of%20Galatians%20&%20an%20Israel%20Exclusive.pdf</a>

How would you like it if someone mistranslated your epistles and then interpreted them in such a way as to deprive you of your inheritance? Would that not make you slightly upset with the translators? Then, because of this type of subterfuge, many in Christian Israel accuse Paul of being the guilty one, not realizing that the KJV translators were doing the devil's work in contradicting the clear, unambiguous, exclusive Covenants between Yahweh and Israel. How would you like to be accused of this false charge? This is what the Paul distorters have done to his epistles. The lousy KJV translation is responsible for this massive confusion. Paul cannot be blamed for the imperialistic agenda of King James.

#### **KINDRED**

Gen. 24:1-7, 36-38: "My kindred" refers to the Shemitic nation of Abraham. No Canaanite wife is permitted for Isaac. Rebekah is the pure White Shemite that Yahweh has selected for Isaac. She is blessed by Yahweh at Gen. 24:58-60

Gen. 25:1-6: The sons of Keturah are sent away so as not to interfere with Isaac's inheritance. These are the Indo-Aryans. They are still a kindred people to the Shemitic Caucasians, but they are not Israelites.

#### HOLY, SEPARATE, SEVERED

"Holy" means "called out." It is only in modern times that the word 'holy' has developed the strictly RELIGIOUS meaning of 'saintly" or "non-sinful." Even so, these modern meanings are derived from "called out." Obviously, the Israelites were hardly ever a non-sinful people, so that definition makes no sense at all. Yahweh has constantly struggled with us because of our sinfulness. Only the Elect, or Remnant, ever achieves righteousness to the degree acceptable to Yahweh for governance of the Kingdom. We are the elect, in spite of our faults, because Yahweh intends to purge the sin out of us. Ex. 19:5-6: "Now, therefore, if ye will obey my voice indeed, and keep my covenant, then ye shall be a peculiar treasure unto me above all people: for all the earth is mine. And ye shall be unto me a kingdom of priests, and an holy nation.

Isa. 6:12-13: "And Yahweh has removed men [#120, AWDAWM] far away [into the wilderness of Europe, which became the regathering place for all White Israelites], and a great forsaking [of His laws, way back in Palestine and the Great Apostasy today] in the midst of the land. But yet in it shall be a tenth [a remnant], and it [the remnant] shall return [to Me, Yahweh], and shall be eaten: as a teil tree, and as an oak, whose substance is in them, when they cast their leaves: so the HOLY SEED shall be the substance thereof."

The Israelites will yet bear fruit, which can be "eaten" when the harvest is ripe. The other 90% are so rotten that they cannot be "eaten." This is also confirmed by the prophetic Church of Laodecia, the End Time Apostasy which so foul that it literally nauseates Yahshua! (Rev. 3:16.) Only the Israelites are spoken of in this manner. None of the historical escapades undergone by Israel apply to any other race. The exclusivity of the Bible is unmistakable, once the fog of universalism is removed from one's eyes. Segregation is not an option. It is mandatory.

"For I am Yahweh your Elohim, the HOLY ONE OF ISRAEL, your Savior: I gave Egypt for your ransom, Ethiopia are for you. Since you (Israel) were precious in My sight, you have been [somewhat] honorable, and I have loved you: therefore will I give men for you, and people for your life. Fear not: for I am with you: I will bring your seed from the east, and gather you from the west. I will say to the north, Give up; and to the south, Keep not back: bring My sons from afar, and My daughters from the ends of the earth; Even every one that is called by my name: for I have created him for my glory, I have formed hmi; yea, I have made him." - Isa. 43:3-5.

These words are spoken exclusively to Israel and to no other people. In fact, these words are part of the dominion Mandate given to the Adamic race way back in Gen. 1:26-31. Yahweh will present the other races and nations to us, once the Remnant has mastered righteousness.

The Hebrew word for 'holy' is qadash. More than anything else, it means "appointed, dedicated, consecrated." The dedication ceremony was the placing of Isaac on the sacrificial altar by Abraham. Only by virtue of this ceremony are Isaac's descendants intended to be "sacred," or "non-sinful." Certainly a priest and God's people Israel should be non-sinful; but that is not what the word means. It means that Yahweh has dedicated us exclusively, setting us apart from the heathen, in order that we might refrain from sin, so that we could provide the world with a holy example, so that we might be the City on the Hill.

Peter confirms this dedicated state for Israel. I Peter 2:9-10: "Ye are a chosen [selected out of many races] Race, a royal [kingly, above all others] priesthood, a holy [dedicated exclusively to Yahweh] nation, a peculiar [different from all other peoples] people, that ye should show the praises of him [to the rest of the world, as in Gen. 12:3] who hath called you out of darkness in to his marvelous light. Such in time past were not a people, but now are the people of God."

Because the Israelites had been already scattered throughout the Greco-Roman world, Peter is simply stating that the New Covenant has again made us One People, via the common forgiveness. Because Israel was broken up into two houses after the death of Solomon, we were no longer ONE PEOPLE. And because we had forgotten His Covenants with us, we were no longer a cohesive culture. But Christ's forgiveness of our past sins made us one people again.

Yahweh is speaking to His people through the apostle Peter, referring to us, <u>using the exact same exclusive language that is contained in the Old Testament</u>, declaring that we are a "chosen" or elect" race, as a "holy nation" and as a "people for God's own possession." By God's grace we occupy a very favored position in His universe. This is what it means to be CHOSEN. If every group, race and nation were likewise "chosen," the word would lose its meaning.

Now, True Israel, what are you going to achieve with this very favored status? Are you going to do as the Judeo-Christians do and destroy your own talents by wasting them on this evil world; or are you going to use your peculiar talents to bring in the Kingdom?

More exclusivity, if you can handle it:

"When Yahweh, thy Elohim, shall bring thee (Israel) into the land whither thou goest to possess it, and hath cast out many nations before thee, the Hittites, and the Girgashites, and the Amorites, and the Canaanites, and the Perizzites, and the Hivites, and the Jebusites,, seven nations greater and mightier than thou; And when Yahweh thy Elohim shall deliver them before thee; thou shalt smite them, AND UTTERLY DESTORY THEM; THOU SHALT MAKE NO COVENANT WITH THEM, NOR SHOW MERCY UNTO THEM." - Deut. 7: 1-2.

Why would God say such a seemingly horrible thing? The Christian Apostasy teaches that those days are over; and that it is water under the bridge. Let's continue to read, and we'll find out what the Christian Apostasy does not want you to know.

"<u>NEITHER SHALT THOU MAKE MARRIAGES WITH THEM</u>; thy daughter thou shalt not give unto his son, nor his daughter shalt thou take unto thy son." – Verse 3.

At Deut. 14:1-2, speaking specifically to the children of Israel, we are told, "Ye are the children of Yahweh your God: ye shall not cut yourselves, nor make any baldness between your eyes for the dead. For thou art an holy people unto Yahweh thy Elohim; and Yahweh hath chosen thee to be a peculiar people unto Himself, above all the nations that are on the face of the earth."

This dedication of one particular people, which Paul refers to as "predestination," as being "above all other nations," is repeated at Deut. 26:18-19, which tells us "And Yahweh hath avouched thee this day to be <u>His peculiar people</u>, as he hath promised thee, and that thou shouldest keep all His

Commandments; <u>And to make thee high above all nations which He hath made</u>, in praise, and in name, and in honor; and that thou mayest be <u>an holy people</u> unto Yahweh thy God, as He hath spoken."

I Kings, 8:51-53, states: "For they be THY PEOPLE, and THINE INHERITANCE, for which thou broughtest forth out of Egypt, from the midst of the furnace of iron: That thine eyes may be open to the supplication of THY SERVANT, and unto the supplication of THY PEOPLE ISRAEL, to hearken unto them in all that they call for unto Thee. <u>For thou didst SEPARATE THEM FROM AMONG ALL THE PEOPLE OF THE EARTH, TO BE THINE INHERITANCE</u>, as thou spakest by the hand of Moses thy servant, when thou broughtest our fathers out of Egypt, O Yahweh God."

At Isa. 44:3, God tells Jacob/Israel: "I will pour my Spirit upon thy seed, and my blessing upon thine offspring. (Not to all people, but Israel's offspring only. The other nations get blessed according to Gen. 12:3.)

Isa. 51: 1-4: His laws are to be promulgated to the other nations by us, True Israel, that we may be a blessing to the nations, as we have done, as history proves. But we succeed in instructing the nations ONLY AS A SEPARATE SPECIES, for when we mix with them, we become like them, and we lose our genetic ability to be that special people, Israel.

"Learn not the way of the heathen." (Deut. 18:9; Jer. 10:2.) When we mix with them, we become like them. We lose our ability to be His chosen people, and they lose the blessings we are able to provide them because we are no longer the genetically-created People He designed us to be!! It IS a matter of genetics, and LOGIC. If we hybridize, we are no longer His Chosen People, Israel. If we become like the heathen, we are no longer Israel. But this is exactly what the Judeo-churches are doing. They are causing White people to act like non-Whites. They are even encouraging racial integration. Apostasy, anyone?

#### The New Covenant Prophesied in the Old Testament

Jer. 31:31-37. Behold, the days come, saith YHWH, that I will make a new covenant with the house of Israel, and with the house of Judah: Not according to the covenant that I made with their fathers in the day that I took them by the hand to bring them out of the land of Egypt; which my covenant they brake, although I was an husband unto them, saith YHWH: But this shall be the covenant that I will make with the house of Israel; After those days, saith YHWH, I will put my law in their inward parts, and write it in their hearts; and will be their God, and they shall be my people. And they shall teach no more every man his neighbour, and every man his brother, saying, Know YHWH: for they shall all know me, from the least of them unto the greatest of them, saith YHWH: for I will forgive their iniquity, and I will remember their sin no more. Thus saith YHWH, which giveth the sun for a light by day, and the ordinances of the moon and of the stars for a light by night, which divideth the sea when the waves thereof roar; YHWH of hosts is his name: If those ordinances depart from before me, saith YHWH, then the seed of Israel also shall cease from being a nation before me for ever.

The ordinances of the space-time continuum have not departed, THEREFORE, the posterity of Israel remains. As long as the universe exists, Covenant Israel exists. This logic is irrefutable. This is why the Judeo-Christians scrupulously avoid quoting the exact terms of the New Covenant. These terms totally refute their Dispensationalist, universalistic anti-theology. They are repudiating everything the Bible teaches.

On the contrary, anything that Yahweh hides can be revealed by Him: "And I will <u>strengthen the house of Judah</u>, and I will <u>save the house of Joseph</u>, and I will bring them again to place them; for I have mercy upon them: and <u>they shall be as though I had not cast them off</u>: for I am the LORD their God, and will hear them. - Zechariah 10:6.

"I am Yahweh. I change not. Therefore, you sons of Jacob are NOT consumed." – Malachi 3:6. "Has God forsaken His people, Israel? God forbid! For I am an Israelite, of the tribe of Benjamin."- Romans 11:1.

The Book of Matthew opens with Yahshua's genealogy. The whole point of this genealogy is prove that Jesus is a direct, racial descendant of David. The prophets declared that the Messiah must be a son of David. (II Sam. 7:11-16; Isa. 9:6-7; Isa. 11:10-13; Matt. 1:1; Acts 2:29-30; Romans 8:29-32.) Matthew and Luke provide proof of this line of descent.

The Gospel of Luke (Luke 3:23-38) gives a more extensive genealogy of Jesus Christ, giving His line of descent, through David, all the way back to Adam and Yahweh. Messiah is also called "son of Man," which means that He is also a pure-blooded descendant of Adam, the one who shows blood in the face. John 7:35. The Pharisees acknowledge that the Lost Tribes still exist and are scattered throughout the Greco-Roman world.

John 8:32-47. The Edomite Jews expose their non-Isaelite sperma. ('Seed' comes from the Greek word sperma.) There is no such thing as spiritual sperm. John 8 cannot be spiritualized. The discussion here is about literal descendants and the false Jewish claim to being the descendants of Abraham. Since these Pharisaic Jews admit that they were "never in bondage to any man," Christ tricked them into admitting that they are the descendants of Esau.

Some Common Misperceptions of Paul's Epistles Corrected

In this section, I will deal with some of the horrible translations of the King James Bible. King James "authorized" this version with the explicit intention of negating the influence of the Geneva Bible, and other versions, which were not approved by the Anglican Church. His motivation was to unify church and state under himself, so as to have authority over both. Englishmen who did not buy into his version were severely persecuted. In fact, the Pilgrims and Puritans were Britishers who fled away from the tyranny of King James. The Bible they brought with them to America was the Geneva Bible. They had no use for the "Authorized Version." It was in response to this ecclesiastical tyranny of King James, still fresh in the memory of the Founding Fathers, that they created the so-called "Separation Clause" of our Constitution, which states that, "Congress shall make no law with respect to the establishment of religion or the free exercise thereof."

Space and time do not permit a thorough analysis of the deliberately universalistic and spiritualized passages contained the New Testament of the KJV. A few important pericopes will be considered.

Romans, Chapter 9.

Because of the false definition of the word 'Gentiles,' many Christians falsely believe that Jesus came to redeem non-Israelites. Contrary to this notion, Paul, in Romans 9 is actually confirming the exclusivity of the Covenants (Rom. 9:3-5) and confirms that <u>Esau is excluded</u> from the Covenants (Romans 9:7-15. "Esau I have hated."). Romans 9 is actually a confirmation of John 8, where the racial distinction between Israelites and Edomites is declared. The Israelites are the "vessels of mercy," (Verse 23) while the Edomite Jews are the "lump of dishonor." (Verse 21.)

The correct translation of Verse 24 is this: "Even US, whom He has called, not of the Judeans only, but also of the Race [ethnos]?" Verse 25 confirms that he is speaking exclusively about the race of Israel.

**Endless Genealogies** 

The genealogies that Paul criticizes at I Tim. 1:4and Titus 3:9 are NOT references to Israelite genealogies. Paul is here criticizing the endless genealogies among the Greeks and other Dispersed Israelites. The Dispersion (James 1:1) consisted of many estranged Israelites. "I am not sent but unto the estranged [or exiled] sheep of the House of Israel." - Matt. 15:24. Many of these estranged Israelites had adopted heathen practices and claimed to have descended from the "gods' of the various nations within which they lived. This is what Paul is criticizing in these passages. He is not challenging the genetic code of True Israel. In fact, Paul goes out of his way to assert that he is an Israelite of the Tribe of Benjamin. (Romans 11:1-2.)

The reference in Titus 3:9 and 1 Timothy 1:4 in which Paul denies the need to search out one's own genealogy, does not conflict with Isaiah's call to Israel. Herod the Tetrarch had ordered the burning of those genealogical records of Israel which were kept in the archives of the Temple, to protect his own rulership. He himself was an Idumean, and therefore he feared any investigation into ancestral records. At that time, of course, the Pharisees were frantically trying to retrace their genealogies in order that they could continue to boast about their ancestry. Paul was also well aware of the class distinction, which would arise when the "heathenised" Israelites, having lost all their records in the captivity, would be joined to the Assembly. - <a href="http://anglo-saxonisrael.com/site/node/84">http://anglo-saxonisrael.com/site/node/84</a>

This discussion of endless genealogies shows that the subject is not the genealogies of the Israelites, but the genealogies of the pagan Greeks:

Some even claim that people who believe in British-Israel "... give heed to fables and endless genealogies, which minister questions, rather than godly edifying which is in faith:" (1 Tim 1:4; Titus 3:9). Is this true?

Answer: First, the Bible is loaded with genealogies. All one has to do is look into the books of Genesis, Numbers, 1 Chronicles etc. and even the New Testament Gospels to see all the genealogies of the people of Israel, and the world in Genesis. Doesn't this contradict what Paul is saying? Absolutely Not! The genealogies that Paul is speaking of are not the Biblical genealogies, but are, "...found in Philo, Josephus and the book of Jubilees, by which the Jews [sic, Judahites and Israelites - Eli] traced the descent from the Patriarchs and their families, and perhaps also to Gnostic 'genealogies' and orders of aeons and spirits. Amongst the Greeks, as well as other nations, mythological stories gathered around the birth and 'genealogy' of their heros [hence Paul's reference to 'fables']. Probably Jewish 'genealogical' tales crept into the Christian communities" (Vines Expository Dictionary, p.262). Clearly these are not the Biblical genealogies Paul was speaking of. Josephus "appeals to the priestly registers and is proud of the royal descent of his mother; he shows that even the priests residing in Egypt had their sons registered authentically in Jerusalem, so as to safeguard their priestly prerogatives (C. Apion., I, vii)." (The Cathloic Encyclopedia, under article "Genealogy"). Philo, "to the various stories and fables told about Moses and the Patriarchs" (ibid).

As for the Gnostics, "[These were] genealogies of spirits and aeons, as they called them, "Lists of Gnostic emanations" [ALFORD]. So TERTULLIAN [Against Valentinian, c. 3], and IRENÆUS [Preface]...Endless" refers to the tedious unprofitableness of their lengthy genealogies (compare Tit. 3:9). - Peter Salemi, <a href="http://www.british-israel.ca/answers.htm">http://www.british-israel.ca/answers.htm</a>

Hence, Paul's condemnation of genealogies concerns the existing mythical genealogies of the Dispersion as well as those of the emerging anti-Gospel sects, whose "genealogy" was traced back to the Gnostic aeons. Not all of the Gnostic sects were anti-Christian, but most of them added ideas and ideology that were either spurious or anti-Gospel. Thus, serious scholarship proves that Paul has no intention of negating the genealogies of Matthew and Luke. Nor do these passages have anything to do with denying the racial genealogy of the Israelites, past, present, or future.

Circumcision Versus Uncircumcison.

Contrary to the doctrine of the Judeos, Paul, in Romans 2-4, is NOT asserting that the "uncircumcision" refers to "Gentiles," or non-Israelites. Rather, Paul is distinguishing between the Israelites of the House of Judah, then living in Palestine (the "Circumcision"), versus the Dispersed Israelites (House of Israel) scattered throughout the Greco-Roman world (the "Uncircumcision").

Remember that the rite of biblical circumcision was made exclusively with the posterity of Abraham, Isaac and Jacob. No other peoples are included in this Covenant. The Circumcision are the Israelites who still practiced circumcision, as the Levitical priesthood still existed in Judea, but it had been commingled with Edomite Pharisees. The Dispersion, adopting the customs of the nations in which they lived, stopped practicing circumcision. Therefore, the Israelites of the Dispersion are the Uncircumcision. This is what Paul means by his usage of these two words. Paul is trying to explain that both groups of Israelites, circumcised or not, were forgiven for their past sins at the Cross. Because that promise was given exclusively to the Progeny of the Chosen People, it has nothing to do with any other people, nor can any other people claim the benefits of inheritance. We have here another example of expert wordtwisting at the hands of the KJV translators, who, by conveying the notion that "Gentiles" are non-Israelites, make the Gospel of none effect.

The history of the laws of inheritance proves that no one but those specifically named in the Will (Testament) can be a party to the Will. No outsiders are ever invited to the reading of the Will. It is none of their business! The New Testament is the story of the delivering of the Will to its intended recipients, namely, the two Houses of Israel. (Jer. 31.) But most Israelites are still clueless that this Will even applies to them. The Epistles of Paul document his strenuous efforts to 1.) explain to the Uncircumcison that they are a Party to the Covenants and 2.) explain to the Circumcison that their forgiveness is a direct result of the unconditional promise to Abraham, Isaac and Jacob that all of these direct descendants will get this inheritance, whether they practice circumcision or not, whether they live in or outside of Judea. Thanks to the poor translations of Paul's writings, as found in the KJV, Paul's words have been universalized; but this universalization is totally contrary to the specificity of the Covenants themselves.

Paul, throughout his Epistles, is constantly explaining to members of both Houses that the unconditional promise to forgive Israelites of their sins (via the sacrifice on the Cross) <u>applies to both categories ("Houses")</u> of Israelites, the circumcised and the uncircumcised. Since the Judeos know nothing of the actual history of the Dispersion, they are forced to make wild speculations that defy the categorical imperatives of Covenant Theology. There is NO WAY that Paul is extending the terms of the Covenants, Promises and Inheritance to anyone else. Paul did not have such authority. Paul did not claim such authority; nor did he do any such thing. The idea that Paul universalized the terms of the covenants to all peoples and races is pure balderdash. It is a total distortion of the Gospel. The devil himself could not have created a more devious, anti-Scriptural doctrine. Actually, he did create it.

Remember that Jeremiah 31 prophesied that the New Covenant would be made to BOTH HOUSES. Thus, the two houses have been reunited, as also prophesied by the Two Sticks prophecy of Ezekiel. Christ's Passover sacrifice on the Cross DID NOT unify all races, as the apostate churches claim today. No Israelite in Scripture has ever made such a claim. This claim is totally contrary to the entire history of the covenants, promises and inheritance, which are exclusive to the posterity of Abraham, Isaac and Jacob. There is simply no doubt about this. When Abraham placed his son, Isaac, on the sacrificial altar, Isaac's progeny were thus being dedicated to Yahweh. Only Isaac's descendants can qualify for this promise. "In Isaac shall thy seed (progeny, descendants, posterity) be called." Only the Anglo-Saxons have ever been called by Isaac's name. This is a very specific branch of the Adamic Race. The rest of the world will be blessed as long as they bless us. They will be cursed if they curse us. Because the Jews have successfully trained the world to bless them and curse us, we have patent evidence of why the world is going to hell in rapid fashion. This deluded world is blessing the progeny of Satan. The beginning of America's precipitous decline into moral degradation began the moment that President Truman recognized the Bastard State of Israeli, that illegitimate, hybrid child of Khazar and

Edomite parents, who claim descent not through the patriarchs of Israel but through their hybrid mothers.

There is a direct, causal relationship between Truman's recognition of that Luciferian State and the chaos that we have descended into since. Since then, American Israel has allowed all sorts of non-Whites to enter into our borders, thus violating all the laws of segregation that Yahweh has commanded us to follow. ISRAEL IS TO DWELL ALONE. We cannot dwell alone in an integrated society.

Jesus Himself declares that, when He returns to judge the nations, He will SEPARATE them, not integrate them: "When the Son of Adam shall come in His glory, and all the holy angels with Him, then shall He sit upon the throne of His glory: And before Him shall be gathered all nations: and <u>He shall SEPARATE THEM ONE FROM ANOTHER</u>, as a shepherd divides sheep from the goats." - Matthew 25:31-32.

Since the Jews reckon their genealogy through the various mothers of their breed, most of whom have little or no Israelite blood, they cannot possibly be the Israel of Scripture. This matriarchal reckoning is totally contrary to the PATRIARCHAL reckoning of genealogy of True Israel, which is amply documented in the Bible.

Paul confirms the law: "But we know that the law is good." Jesus was "born of a woman, according to the Law." (Gal. 4:4) This means that His genealogy is purely Adamic, through the patriarchs. His mother, Mary, was also of royal blood, being descended from David. Joseph, his legal father, or "stepfather," was also a descendant of David. Therefore, Yahshua's genealogical descent is totally in conformity with Hebrew law and the Covenants. His genealogy is PERFECT, just as Noah's was. Mary's genealogy is reckoned through her father, Heli, at Luke 3:23. Heli was Mary's father and became Joseph's father-in-law. Since the expression, "father-in-law" was not in common usage, verse 23 simply declares Joseph to be the "son of Heli." Jesus said, "I am the ROOT and the OFFSPRING of David." (Rev. 22:16.) Because Mary was a descendant of David, so was Yahshua.

It is amazing that the Jews claim that Jesus could not have been the Messiah because He did not have an earthly father — while they themselves reject the patriarchal lineage!!! This is nothing but incredible sophistry and hypocrisy! But the prophecy concerning the Messiah simply states that He will be the offspring of David. And David's genetic code was transmitted to Yahshua through Mary. That is the bottom line. Furthermore, who better than the Holy Spirit could be your father?

From Wikipedia, which is a Jewish-owned service, we are told, under the heading of "Who Is a Jew?" *According to* Halakha (*Jewish law*), only <u>a convert or a child born to a Jewish mother is counted as Jewish</u>. A child with a Jewish father and a non-Jewish mother is considered a non-Jew.

So, who are the Jews to criticize Christ's genealogy when they themselves admit that they do not follow a partriarchal reckoning? Hypocrisy, thy name is Judaism!

Israel, the Anointed People, Both Judah and Israel

"And many of the people believed on him and said, When Christ [Messiah] cometh, will he do more miracles than these which this man hath done? The Pharisees heard that the people murmured such things concerning him; and the Pharisees and the chief priests sent officers to take him. Then Jesus said unto them, Yet a little while am I with you, and then I go unto him that sent me. Ye shall seek me and shall not find me: and where I am thither ye cannot come. Then said the Jews among themselves, Whither will he go, that we shall not find him? will he go unto the DISPERSED among the Gentiles (Nations) and teach the Gentiles?" – John 7:35.

This verse proves that even the rabbis of His day understood that the Dispersed Tribes were scattered throughout the Greco-Roman world.

The Judahite scribe, Josephus, tells us "...wherefore, there are but two tribes in Asia and Europe <u>subject to the Romans</u>, WHILE THE TEN TRIBES are beyond Euphrates till now, and are <u>an</u>

<u>immense multitude</u>, and not to be estimated by numbers." Antiquities of the Judahites, Book XI, chapter V, Para. 2.

II Esdras 13:39-46: "Those are the Ten Tribes, which were carried away prisoners out of their own land in the time of Osea the King, whom Salmaneser the King of Assyria led away captive."

The Book of James opens with this dedication: <u>"To the TWELVE TRIBES SCATTERED ABROAD,</u> GREETINGS."

Psalm 20:5-6. "WE will rejoice in Your salvation...The Lord saveth His anointed." Jesus is the Savior, not the one to whom salvation was promised. Get it?

Psalm 28:8-9: "Yahweh is THEIR strength, and He is the saving strength of His ANOINTED. <u>Save</u> your peope and bless Your Inheritance: feed THEM also, and lift THEM up forever."

II Esdras 711: "Even so also is Israel's portion. <u>Because for their sakes I made the world</u>; and when Adam transgressed my statutes, then was decreed what now is done."

I John 2:27: But the anointing which ye have received of him abideth in you, and ye need not that any man teach you: but as the same anointing teacheth you of all things, and is truth, and is no lie, and even as it hath taught you, ye shall abide in him.

These examples prove conclusively that the word 'anointed' does not always refer to the individual, Christ Jesus. The KJV often mistranslates 'anointed' as referring to the person of Yahshua, when it in fact refers to the ANOINTED PEOPLE, the whole house of Israel, meaning all twelve tribes. It clearly does not refer to Yahshua in Gal. 3:28.

2 Cor. 1:20-22 "Now He who establishes us with you in Christ <u>and has anointed us</u> is God, who also has sealed us and given us the Spirit in our hearts as a guarantee."

Paul is directly referencing the promise of the New Covenant in Jer. 31. Here is the true promise of salvation, as it applies to True Israel: Only those Israelites of Adamkind, through the redemption at the cross and the restoration of His Remnant at the Second Coming, will inherit immortal flesh bodies, protected by the Holy Spirit. This is the true meaning of "salvation," for Israel and the White Race. The other races, which were indeed created by Yahweh Elohim, will continue to exist; but they will no longer inhabit our lands. The Law of Segregation will be forever enforced. Hybridization will henceforth be a capital offense and will be punished accordingly. Here is how Isaiah puts it:

"Therefore I will shake the heavens, and the earth shall remove out of her place, in the wrath of Yahweh of hosts, and in the day of His fierce anger. And it shall be as the chased gazelle, and as a sheep that no man (#120, awdawm) takes up: they shall every man (#376, iysh, mortals of all races) turn to his own people, and flee every one into his own land." - Isa. 13:13-14.

The Blacks will go back to Africa. The Orientals will go back to China. The Mexicans will be sent back to Mexico. The Jewsraeli Viper State will be wiped off the face of the map; and we Adamites will keep the lands that Yahweh has given to us. And there will be peace and prosperity everywhere, after Adamkind gets restored to the condition intended for our parents, Adam and Eve. There will be no more race-mixing! Praise Yahweh!

Matt. 25:32-33 confirms Isa. 13:13-14.

Since only Adamkind was promised dominion, these other races will have to submit to our dominion, as stated in Gen. 1:28-30. Even for them, their best days are ahead of them, because the Perfidious Jew, the hybrid race of the fallen angels, will finally be wiped off the face of the earth. Is this a radical teaching? This is what the Bible teaches, in no uncertain terms!!!

"One Blood"

Acts 17:26 is another verse that is commonly cited by those who opt for the unity of the races doctrine. This verse says: "He has made from one blood every nation of men to dwell on the face of the earth." This verse does not mean that all races have the same blood genetically, anymore than the statement, "there

is one flesh of men" (1 Cor. 15:39), means all races have the same skin. Daily observation of the different skin pigmentations tell us this is not the correct interpretation of 1 Cor. 15:39. Also, medical science has well established that the various races do not have the same genetic makeup of blood (see, Races and People, by Dr. William Boyd, 1955, p. 145). Furthermore, the word 'blood' is not in the original Greek text. It was added by the translators. Most Bible commentaries on this verse state that, "The best texts omit the word 'blood'."

More tampering with text by the translators!

Even if the word was originally there, it does not change the meaning of the Greek word ANTHROPOI ("men"), which was only applied to White men by the Greeks. Therefore, the true meaning and intent of Acts 17:26 is this: "He has made from one every nation of Adamkind to dwell upon the face of the earth." Paul is actually referring to Noah, the one man from whom all of the White nations of the world have descended. His audience understood what he was saying. They were NOT multiculturalists!

The passage at Acts 17:18-32 is addressed to certain Epicureans and Stoics of the Dispersion. This group would have included both White Japhethites as well as Shemites, going all the way back to the table of nations in Genesis 10, all of which were White Adamites. Verses 28 and 29: "For in Him we live and move and have our being; as certain also of your [Epicurean and Stoic] own poets [philosophers] have said, Forasmuch then as we are the offspring of God [through Adam and Noah], we ought not to think that the Godhead is like to gold, or silver, or stone, graven by art and man's device [as the heathen nations do!]."

Paul is telling these Adamites that they should not imitate the heathen nations. This is Old Testament theology, folks.

Arnold Kennedy has done the most thorough research on this passage. His document, entitled, "'Of One Blood' – Acts 17:26," goes into the subject of the word 'haimatos:'

"However, the word 'blood,' Greek 'haimatos,' as in the Stephens' text and the King James Version, is omitted by practically all authorities. Bullinger states, 'The texts omit 'blood,' and Scofield agrees with, 'Blood is not in the best manuscripts.' Four of six editors of the Stephens' text (A.V.) omit the word. It is also omitted by the following: Wescott and Hort, Panin, the Concordant Version, the Diaglott, Douay Version, the vulgate, Revised Version, the Nestle text & Revised Standard Version, and by Ferrar Fenton. Moffat has 'from a common origin.'"

"No Respecter of Persons" Has Nothing To Do With Race

It is true that Paul spoke these words in Acts 10:34, but Judeo theology is completely in error when suggesting that these words mean that we should "respect" the people of other races. The expression, "no respecter of persons," has nothing to do with the subject of race. That is a modern misrepresentation of biblical reality. The phrase is also taken out of context. The phrase always refers to rich versus poor, strong versus weak, within Israel. Since we are not to associate with non-Israelites, except on a national basis, with our leaders negotiating with their leaders, we are not expected to defer the those of another race in personal matters that should not even occur, were we obeying Yahweh's Law of Segregation..

The fact is that Yahweh does not have equal regard for all races. Israel is the apple of His Eye. We are His Chosen People, and no other people has He regarded as He regards us. It might be said that we are His "special project," the posterity that is to redeem this planet against the anti-Christ and his fallen angels.

The first occurrence of the phrase in Scripture is at Lev. 19:15, where only Israel is being addressed, since Moses is giving us the Law: "Ye shall do no unrighteousness in judgment: thou shalt not respect the person of the poor, nor honor the person of the mighty but in righteousness: but in righteousness shalt thou judge thy neighbor."

In other words, we are not to show favoritism to an Israelite person because of wealth, status, rank, position, within our own society.

Since Israel is to dwell alone and separated from the other races, the question of defering to non-Israelites never comes up. Obviously, we are not to mistreat strangers, but the strangers of other races are not even supposed to be among us in order to disrespect them.

In Gal. 3, Paul's soliloquy about neither male nor female, Judean or Hellene is also strictly within the nation of Israel, because both the Greeks and Romans had numerous Israelites living within those territories, as Josephus clearly attests. Josephus was one of them! Paul is simply telling the Israelites that they all have been forgiven, regardless of rank, status, sex, or circumcision.

The Law Was Given Only to Israel

Deut. 27: 9-10: Moses and the priests spoke to all Israel, saying, "Take heed, and hearken, O Israel; <u>this day you are become the people of Yahweh Elohim</u>. You shall therefore obey the voice of Yahweh your Elohim and do His commandments and His statutes, which I command you this day."

Psalm 103:7: "Yahweh made known His ways to Moses, His acts to the children of Israel."

Deut. 4:7-8: "For what [other] nation is there so great, who has El so near to them, as Yahweh Elohim is in all things that we call upon Him? And what nation is there so great, that has statutes and judgments so righteous as all this law, which I set before <u>you</u> this day?" All scholars agree that the Mosaic Law was delivered to Israel and only Israel.

Psalm 147:19-20: "He showeth His word unto Jacob, his statutes and His judgments unto Israel. He hath NOT DEALT SO WITH ANY OTHER NATION."

Ezra agrees: "For I have seen how thou [Yahweh] sufferest them sinning, and hast spared wicked-doers: and hast destroyed [the evildoers of] thy people, and hast preserved thy enemies...I do not remember how this way may be left: are they then of Babylon better than they of Zion [Israel]? Or is there any other people that knoweth Thee besides Israel?" — II Esdras, 3:30-32.

See also Romans 9:4-5.

Clearly and unambiguously, the Bible recognizes only True Israel as His People. No other people qualifies; and only Israel was given the Mosaic Law.

#### ANTHROPOS (MAN)

The Greek word 'anthropos' is the common word for a male person of the Greco-Roman world, just as the Greek word 'gyne' is the common Greek word for a woman. This fact is proven by the way in which 'anthropos' is used in the Septuagint. For example:

Deuteronomy 17:5. "Then you shall bring out that anthropos or that woman, and you shall stone them with stones"

Deuteronomy 22:24. "They shall be stoned with stones, and they shall die, the young woman, because she did not cry out in the city, and the anthropos, because he violated his neighbor's wife."

Isaiah 4:1. "Seven women shall take hold of one anthropos, saying, we will eat our own bread, and wear our own raiment; only let your name be called upon us, and take away our reproach."

Jeremiah 51:7: "to cut off anthropos and woman of you, infant and suckling from the midst of Judah..."

Now, for the New Testament:

Matthew 19:5 "*Therefore shall an* <u>anthropos</u> *leave his father and mother, and hold fast to his wife.*" (also in Ephesians 5:31)

Matthew 19:10 "If such is the case of an anthropos with his wife, it is better not to marry." I Corinthians 7:1 "It is good for an anthropos not to touch a woman."

Since the law was given exclusively to Israel, these statements, using the word *anthropos*, cannot apply to any other group. Furthermore, neither the Greeks, many of whom were Japhethites, nor the Israelites of the Greco-Roman world, considered non-Whites to be *anthropos* of their own race. The Greeks and Romans never considered the other races to be part of this COSMOS (world-order), which was run exclusively by ANTHROPOS (White, Adamic Man). Non-whites, whether of Oriental or Black origin, were never accorded citizenship status until much later in Greek and Roman history. In both cases, the half-breed offspring of Free Whites and non-White slaves were not given citizenship status *until these cultures were in the throes of fatal decline*. From this history, which includes myriads of statues and artwork of Whites only, we know that the Greco-Roman world was an exclusively White *anthropos* world. This reality is assumed by and reflected in the language of the New Testament.

There is simply no doubt that the Greco-Roman world was both Hebrew and Indo-Aryan:

It is common to speak of "civilizational ideas," but do they exist? For example, are the doshas of Ayurveda peculiarly Indian since they are a tripartite classification that is basic to the Vedic system of knowledge? Plato introduced a similar system based on three humours into Greek medicine, with a central role to the idea of breath (pneuma in Greek). But this centrality of breath (prana in Sanskrit) is already a feature of the much older Vedic thought.

So do we agree with Jean Filliozat (1970) that Plato borrowed the elements of the wind, the gall, and the phlegm, from the earlier tridosha theory, and that the transmission occurred via the Persian empire?

Others claim that any similarities between the Indian and the Greek medical systems <u>must be a result of the shared Indo-European heritage</u> and what may appear to be Indian is actually Indo-European. Dumezil's demonstration that tripartite categories operated elsewhere in the Indo-European world supports this latter view. Dumezil argued that all Indo-European religions have three hierarchical functions: sacred sovereignty, force, and fecundity, represented by the categories of brahman, rajan (or kshatra), and vish.

Religious and political sovereignty is conceived as a dual category: the magician-king and the jurist-priest. In India, this duality is in the roles of the rajan and brahman; in Rome, of rex and flamen. Even the names are similar!

In his Mitra-Varuna, Dumezil (1948) shows that the magician-king (Varuna in India or Romulus in Rome) initiates in violence the social order that the jurist-priest (Mitra in India or Numa in Rome) develops in peace. Magical sovereignty operates by means of bonds and debts, whereas juridical sovereignty employs pacts and faith. This pattern is repeated in time: in the cult of Christ as the "son" he is the "intercessor" and savior juxtaposed to the avenging, punishing father."

There is similarity between the Indian and the Greek religions as also in the society sketched in the Mahabharata and Homeric poems. Metempsychosis [reincarnation] is known in both places. The imagery of the "world-egg," so central to Vedic thought, is described in the later Orphic legends. According to Rawlinson (1975), "the resemblance between the two legends is too close to be accidental." – Indic Ideas in the Graeco-Roman World, by Subhash Kak, PhD.

All of the nations named in Genesis 10 were exclusively White. The rulership of these nations remained exclusively White, even after non-White slaves were brought in, after military subjugation. In no way did any of these Adamic civilizations treat race-mixing as an acceptable practice. Indeed, the Hindu caste system is a holdover from Aryan dominionism in India. Racial exclusivity was, quite simply, the norm, not the exception, in the White, Greco-Roman world. No anthropologist, except for Jewish deceivers, has ever stated otherwise.

By the time of Christ, most of the Greeks of the Greco-Roman world were actually Japhethites and Israelites of the Dispersion, and most of the Romans were pre-Dispersion Israelites of the House of Zarah-Judah, as Rome, Troy, Spain and Britain were settled by Zarah-Judah and Dan even before the Exodus; and it was only the Dispersed Israelites of the Greco-Roman world who had any interest in going

to Jerusalem for any Israelitish feasts. Nor would any non-Israelites be allowed to attend these Feasts. This is just as true of the Magi, who were of the Parthian (Pharez-Judah) nation, as it was of the various "nations" represented at Pentecost in the Book of Acts. The Parthians were a blend of Persian (Aramaic Shemite) Whites and Saxon Whites. They were ruled by kings descended from Pharez and by priests of the house of Levi. The Scythians were a blend of Japhethites and Israelites who were not ruled by Pharez-Judah. Their territory was north of Parthia, well into Russia, and extended far into the East, even into China (the Tocharians) and was well established in the eastern and northern parts of Europe (as the Veneti, Frisians, etc.). The Veneti were Japhethites (Slavs), who were the traders that delivered goods into Venice from the rivers of eastern Europe and Russia.

All of these nations were White, from top to bottom; and they all considered non-Whites to be inferior races. When these White tribes confronted Mongolians or Africans, there was war, not integration. This is the racial COSMOS that the Israelites were brought up in; and the Apostles display this racial reality when they are confronted by non-Israelites.

At Acts 2:22, Peter addresses the assembly with the words, "Ye men of Israel." These men were White, Adamic Israelites who had been scattered by the various dispersions and had settled in the various parts of the Greco-Roman world. Only such persons would even be allowed into the congregation of Israel. Indeed, the death penalty was enforced for any non-Israelite who tried to enter the Temple. The plaques stating this death penalty warning still exist on the Temple walls.

In *Apion* 2.8; 103-109, Josephus describes the Temple grounds. The Temple had four courts, each with restrictions on who could enter. The outer court was open to all, including non-Israelites, except menstruating women. The second court permitted only Israelite men and non-menstruating Israelite women. The third court permitted only Israelite men. Finally the fourth court was restricted to priests who were properly attired for the performance of their priestly duties. Only the High Priest dressed in his regalia could enter the inner sanctuary (*adytum*), the holy of holies.

The question for the Jews and Judeos is this: At what point were all of these segregationist rules suspended? And by whom? Nothing like this was ever done by either Jesus or Paul. Rather, the integrationist philosophy of the Jews and Judeos is a figment of their hyperactive imaginations and their anti-White, anti-Christ agenda.

At Acts 1:6, the Israelites assembled at Jerusalem realized that they are being confronted by the risen Christ. They ask Him, "Will You at this time restore again the kingdom to Israel?" Notice, they do NOT ask, "Will you restore the kingdom to all races of the world?" Since this is the NEW TESTAMENT, and it was AFTER The Resurrection, there is no question that the Apostles entertained any notion that the covenants were to be promised to anyone other than Israel. That notion is a purely modern, that is, apostate, notion. It is only because of the dilution and perversion of the original Greek and Hebrew text that the modern apostasy of universalism and miscegenation is salable to a gullible Caucasian Christian.

You will note that Paul only speaks to the Romans as being capable of being "grafted in" precisely because they were Israelites, not "Gentiles," in the Jewish sense. They were still children of the Covenants even though they had left the main body of Israel BEFORE the Exodus but AFTER the Covenants were made with Abraham, Isaac and Jacob. Only because they were part of Caucasian Israel could they be "grafted" back into the fold. This is also the true meaning of the vision Peter had concerning clean and unclean "food." Acts 10:28 clearly states that the meaning of this vision is about MEN (anthropos), not food; and these men are Israelites of the Dispersion being equated with the Judahites of Judea. Jer. 31 is again verified.

Rev. 21 is about the Bride of Christ and the coming of the New Jerusalem. This New Jerusalem is the Lamb's wife. The Lamb's wife is described as being the "twelve tribes of the children of Israel." (Rev. 21:12.) No other nations are considered as being part of the Bride of Christ. There is simply no way that the word 'Israel' can be redefined to mean "all races of the world." Yet, this is what the false priests of the modern apostasy all teach. Rev. 21 and 22 are simply stating the fact that Dominion Mandate of

Gen. 1 will be established upon the Second Coming of Yahshua Messiah, concomitant with the Restoration of True Israel..

The Last Word: GENTILE.

One of the most abused and misunderstood words of Scripture is the word 'gentile.' This word is actually of Latin origin and it NEVER had the meaning of "those who are non-Jews." This meaning is of modern origin and is based on the false Jewish idea that Jews are Israelites and that all non-Jews are so-called "Gentiles." The reality is that the Latin word 'gentile' was substituted for the Greek word ETHNOS, which simply means, "race, tribe." In the original Latin, the word meant, very specifically, a person of one's OWN RACE OR TRIBE. Hence, we see that the Jewish-inspired definition of the word is the exact opposite of the original meaning. The Jews use it to designate non-Jews, when, Scripturally, the word most often refers to the Israelites of the Dispersion (dated 745 BC). Just as the modern word, 'race,' can refer to any race, the Greek 'ethnos,' the Hebrew 'goy' and the Latin 'gentil' can refer to any race, so the context of a particular passage must be taken into consideration before determining which race is being spoken of.

Race-mixing with non-Whites was simply unheard of in the Greco-Roman world. It only occurred among the wealthy who brought non-White slaves back to Greece and Rome from the various military campaigns. Race-mixing was taboo in America as late as the 1950's. It was the Jewish-owned televangelist networks that began promoting the idea that the races must integrate; and it was the Supreme Court under the Jewish rabbi, Earl Warren, that urged Eisenhower to forcibly integrate Mississippi's schools. It wasn't the Bible that changed. The Bible Belt of the South was just fine with segregation since 1776. What changed? It was the pastors of apostate Judeo-Christianity who started changing THEIR doctrine, claiming that today, after 2,000 years of segregation, that the Bible must be interpreted differently!

Although Strong's Concordance includes, as the last entry, the Jewish definition of the word 'goy' as "foreign nation," a careful study of the passages in which this word is used shows conclusively that the word 'goy' is used far more often of Israelites than of any other nation, so "foreign nation" is a false definition by the standard of Biblical usage. This false definition has been picked up by the deceived "Gentiles" who don't know how the Jews have distorted the definitions of words for their own, supremacist purposes.

Here is how the Ensign Message describes the deception that has come about, regarding this word: THE ENGLISH WORD "GENTILE" A SAD ERROR IN TRANSLATION

An examination of this word, and how it came into the English language from the Bible, shows that it was evidently coined by the translators of the Authorised Version to their individualistic understanding that excluded the main national theme of Israel from the New Testament. Ignorant of the whereabouts of dispersed Israel and the Nation building in the Isles of the West, they considered "Israel" and "Jew" as interchangeable terms as denoting the same people mostly resident in the Holy Land and nearby districts. They used the word "Gentile" to describe all peoples other than those termed "Israel" or "Jew." They took great liberties, in translating the Greek word ethnos in a variety of ways - Gentiles 93 times, heathen 5 times, nation 64 times, people twice with the greatest inconsistency including the Greek word hellen, which they also indiscriminately rendered "Gentile."

The collective word ethnos which means - "nation" - is not applicable to an individual. A person cannot be addressed as a "nation." The idea that a person can be called a "gentile" - stems from incorrect translation of the original word.

The English word - Gentile - has its origin from the Latin gentelisis and the French gentil, both derived from the root stem gens, a Latin word meaning - "A Selected Clan or Race of the same stock," in a collective sense.

Had the translators used the word - "nation" - in every instance, the context would reveal whether ethnos was applicable to the nations of Israel or nations of non-Israel race.

<u>Church leaders erroneously read the Pauline Epistles as addressed to alien peoples of non-Israel race-termed "Gentiles."</u>

In doing so they introduce doctrine so full of contradictions as to subvert the Gospel of the Kingdom as taught by Jesus and the message the Apostles were commanded by HIM to expound to the lost sheep of Israel and not alien "Gentiles" (Matthew 10:5-6).

The true Kingdom Gospel - covered by the Mystery of the Kingdom - (Matthew 13:11), was revealed only to HIS Disciples and those who had ears to hear. Blind Israel was not immediately receptive to the message and those of the early centuries A.D. - lost in a maze of Christian dogmas - <u>had relegated God's Servant Nation to the limbo of forgotten legend</u>.

In the light of new knowledge the old mistakes can be accounted for. It can now be seen that the Bible contains a "cover story" implanted for the very purpose of concealing Israel from the world at large. Instead of following the unchanging purpose of Yahweh in the Israel race and the political base of the Gospel of the Kingdom, Christians were carried away with the individual aspects of personal salvation and substituted a gospel that excluded the national theme.

Undoubtedly the translators of the A.V., biased by this attitude, misapplied the meaning of the original word for nation and substituted religious connotations to it - such as "Jews" and "Christians." In proof of this corruption see our modern English dictionaries, which continued to perpetuate the error, an example - according to "The New Hamlyn Encyclopedic World Dictionary":

"Gentile = of or pertaining to any people not Jewish."

The absurdity of such an error is profound, and that it should have been handed down to this day and age without correction, shows to what an extent tradition may lead astray. The muddle can only be solved by accurate definitions:

"Jewish" denotes a person professing - "the Jews' religion" - (Gal. 1:13) and is not applicable to a race. Directly opposed to the above, gens, the root stem of Gentile, appertains to people belonging to the same family, clan or nation - and NOT to a heterogeneous collection of many different races of people. The same bias that actuated the translators of the A.V. to distort the meaning of ethnos, is evident also with the Greek words genes, genos and gennema, whose primary meaning in each case is race. In many passages they confused the racial theme by rendering "race" as "generation" - striking examples of this, where "generation" makes no sense with the context, are - Matthew 3:7. 12:34; 23:33, 24:34, Mark 13:30; Luke 3:7; 21:32; 1 Peter 2:9.

Summary: The Pattern of Exclusion, From Genesis 1 to Revelation 22

In Gen. 1, the dominion covenant was given to the Adamic race exclusively. In Gen. 2, a specific man and a specific woman of AWDAWM were selected to be the leaders of this race. Yahweh personally breathed the breath of life into them, so that they could produce a dedicated bloodline. They were even promised an immortal posterity if they obeyed Yahweh's laws of separation, but Eve was seduced by the Nachash critter and Adam tasted the fruit of miscegenation as well. This is what led to the Fall. The Hebrew word, *nachash*, has its root in the Aryan word, *Naga*, meaning the fallen ones of the primordial world. *Naga* is cognate with such words as ANAKIM (the fallen angels of Scripture) and with the Chaldean ANUNAKI. We can also see that the Hebrew root is similar to the English NAKED and the Germanic NAKT (naked) and even NACHT (night, dark), because what Adam and Eve did (forbidden sex) required them to be naked and they mated with the children of darkness and probably with the dark-skinned *chay* of the field, in the Garden.

The pattern of exclusion that Scripture details is designed to get the Adamic Race back on its segregated path. The pattern of exclusion names only White patriarchs has the leaders of the Race.

From here on the covenants are made with an ever more exclusive line of descent, even excluding other existing White tribes.

Abrahamites Isaac Rebecca Esau-Edom Isaac's Sons (Saxons) Jacob several wives Edomites

(THE TWELVE TRIBES OF ISRAEL)

The Twelve Tribes of Israel are the final exclusionary group. We are the heirs of the Promises. The pattern of exclusion demonstrates that the Covenants, Promises, Dominion and Inheritance devolved from Adam and Eve down to Jacob and his twelve sons. All other ethnicities, including the other tribes of the White Race, are excluded from these Covenants. The Bible makes all of this explicit and clear, as this record has demonstrated. However, it is also clear that tribal membership is based on the father. Intermarriage between Israelites and Adamic Aryans was always permitted. However, the posterity was always reckoned through the father.

So, if the Bible goes to extremes in order to sever even the close Adamic kinsmen of Israel, how in the world are "all races" going to be included? The pattern of exclusion proves that universalism is a crock.

Abraham, Isaac, Jacob and his twelve sons all married Shemitic women. Once these women were selected, the posterity of Israel continued through the patriarchs. Intermarriage between men and women of the different tribes meant that, for example, the offspring of an Asherite woman and Simeonite male would be reckoned as Simeonites. Although it is impossible for us to keep track of all of this genealogy, Yahweh knows all; and He has His reckoning all set for the New Jerusalem of Rev. 21, which consists exclusively of the 144,000 of the TWELVE TRIBES OF ISRAEL. This prophecy cannot be spiritualized. It is genetic reality, according to Yahweh's own laws, will and testaments.

Finally, if an Israelite man marries a White woman of a non-Israelite nation, such as a Slavic woman of Japheth or a Shemitic woman of Armenian, Scythian or Parthian extraction, those offspring will be reckoned as Israelites. However, if an Israelite woman marries a non-Israelite White man, her offspring will not be counted as Israelites. Therefore, her children will not be Heirs of the Covenants. Nevertheless, all White non-Israelites, who call upon His Name and obey His commandments, will have a share in the Kingdom, but rulership of the Kingdom will devolve exclusively upon the Israelite patriarchate.

"Japheth shall dwell in the tents of Shem." This prophecy came exactly true as the Davidic Throne, through both Zarah and Pharez, continued through the Emperors of Rome (First Reich) and then through

the Kings and Queens of Europe (Second Reich). The royal Houses of Europe were all cousins to each other; and they are all descendants of the Shemitic House of David, whether their subjects were Celts, Iberians (Hebrews), Cimmerians, Scythians, Israelites, Saxons or Slavs. Hitler's "Third Reich" was premature. It was not based on Scripture. It is yet to come.

What the world knows as Western Civilization was organized by the Caucasian Israelites, who are the direct descendants of Abraham, Isaac and Jacob. Under our leadership, the other branches of the White race were unified into one great culture, based on honor, honesty, inventiveness, hard work and common law. All of these qualities were grafted into Caucasian Israel as a result of the promise of Jer. 31, the New Covenant, being fulfilled in True Israel. Christian Jurisprudence, with all of its stress on justice and fair play, was brought to the world by the Anglo-Saxon, Caucasian people. The Jews had nothing to do with it. In fact, the Jews have been a subversive force since Gen. 4:1, where Cain was cursed with the inability to farm. The Jew wanders the landscape until he finds a nice, cozy Saxon state to feast off of. We are the builders. The Jews are the destroyers. It can be stated as a plain fact of history that the primary pastime of the Jewish people is to subvert and destroy Adamic/Saxon nations. They have done this through usury, Talmudism, war-mongering, degradation of morals, Zionism, communism, etc. A primary feature of all of these methodologies is their commitment to "integration" for Whites.

It should be obvious to everyone that Satan is the author of these theologies and methodologies; and the Jewish people are Satan's minions working overtime for their lord and master, Baal.

It is We, not the Jews, who brought the common law, which is biblical law – from Moses to the judges to David to Yahshua to King Alfred the Great to the Declaration of Arbroath to the Magna Carta to the US Constitution - into prominence in the modern era. The Jews have done everything they possibly can to subvert these freedom-loving declarations. It is we Anglo-Saxons who are Yahweh's servant race. The Jews have always been anti-Mosaic in practice while publicly proclaiming the lie that Judaism is a Mosaic religion. The Jews have NEVER authored any liberty-producing legislation. On the contrary, their every move is profit-motivated, subversive, deceptive, supremacist and tyrannical.

Jesus Christ, the self-declared "son of Adam (AWDAWM, ANTHROPOS)," had a two-fold purpose in His sacrifice at the Cross: 1.) redeeming the Adamic Race from the Fall and 2.) forgiving the past sins of the Israelites, to whom the Law was delivered. The fact that He was an Adamite and a descendant of David gave him the qualifications for this dual deliverance. The Enmity declared at 3:15 does not get resolved until the Second Coming, when He will return with His holy angels to smite the Edomites and anyone who has allied himself or herself with them (Mystery Babylon).

#### Conclusion

"Yet I planted you a choice vine, wholly of pure seed. How then have you turned DEGENERATE and become a wild vine?" Yes, this verse is in the Bible, but it is not the KJV translation. It is the Revised Standard Version, which gets the context right, as Jeremiah is enumerating the sins of Israel. In Jer. 3:1, He says, "You have played the harlot with many lovers." Since Yahweh is speaking to the whole nation of Israel, the "many lovers" can only be the other nations that Israel is forbidden to intermarry with!

When it is time for the children of Israel to be punished for their sins, He says, "I will appoint over them four kinds of destroyers, says Yahweh: the sword to slay, the dogs to tear, and the birds of the air and the beasts of the earth to devour and destroy." – Jer. 15:3. (RSV)

Yahweh punishes our national fornication by using those very nations to kill us, by turning them into destroyers of Israel. How many times has this happened to our once glorious, Whites-only societies?

Nevertheless, He will not totally abandon us. He will bring us back to our senses, breaking the matrix of deceit, the bonds of delusion and apostasy! Not only that, the rest of "humankind" will acknowledge that WE are HIS CHOSEN PEOPLE. Observe:

"And their seed shall be known among the nations, and their offspring among the people: all that see them shall acknowledge them, that they are the seed which Yahweh hath blessed." – Isa. 61:9.

Amos 3:2 puts it this way: "YOU ONLY HAVE I KNOWN OF ALL THE FAMILIES OF THE EARTH."

Isa. 43:21: "This people have I formed for Myself; they shall show forth My praise." Numbers 23:9 – "Behold it is a people that shall DWELL ALONE."

What part of the expression "dwell alone" don't you understand? We are to segregate ourselves from all the other races.

Deut. 32:9: "For Yahweh's portion is His people. Jacob is the lot of His inheritance."

Deut. 33:28-29: Israel then shall dwell in safety <u>ALONE</u>: the fountain of Jacob [shall be] upon a land of corn and wine; also his heavens shall drop down dew. Happy art thou, O Israel: <u>who is like unto thee</u>. O people saved by the <u>LORD</u>, the shield of thy help, and who is the sword of thy excellency! <u>and thine enemies shall be found liars unto thee</u>; and thou shalt tread upon their high places.

Instead of trodding down the heathen idolaters, today's Judeo churches are inviting them into their homes and churches, just like the reprobate Israelites of Palestine! The Great Apostasy will be judged along with the Synagogue of Satan.

I Kings 8:53: For <u>you did SEPARATE THEM from among all the people of the earth, to be Your</u> inheritance."

Despite all of this segregationist language, the world believes that the mongrelized Jews are "Israel." But, because Yahweh's servant people, Israel, have been blinded to their true Identity, many of us, thanks to Jewish propaganda, remain in the dark. Paul tells us at Romans 11:25, "...that blindness in part is happened to Israel, <u>until the fullness of the nations be come in</u>." Now that the New World Order has done away with sovereign nations, our blindness is finally beginning to lift. Do you see how easy it is to discern Paul's true meaning, once the blinders of mistranslation are removed?

In Matt. 13, Jesus is asked by the Apostles why he speaks in parables. His answer is exclusivist. At verse 11, He answers, "Because it is given to YOU to know the mysteries of the kingdom of heaven, but to THEM it is not given." Clearly, the gospel is not for everybody. It is only for a few, even within Israel. "Many are called but few are chosen." Yet, today's apostate churches unanimously teach that we are all "saved" by mere belief in Jesus Christ. The exclusivity of the covenants has been replaced by the heathenism of the churches, who profit by having more butts in the pews and more shekels in the basket. At verse 14, regarding those people for whom this Gospel is not intended, He says that He has no intention of preaching to them, "lest at any time they should see with their eyes, and hear with their ears, and should understand with their heart, and should be converted, and I should heal them."

Why would Jesus say such a thing? The obvious reason is that there were always Pharisees in the audience, seeking to entrap Him with His words. Yahshua never minced words with these Pharisees. He condemned them at every turn. He did not even TRY to convert them. At John 10:26, he tells them, "But you believe Me not, because YOU ARE NOT OF MY SHEEP." So much for everyone being "one in Christ." Also, there were various non-Israelites in the crowds, to whom the gospel does not pertain.

In Matt. 15, the Canaanite woman asks to be given the "bread of life," but Jesus tells her, in Covenant language, "It is not fitting to take the children's bread and give it to the dogs." Yahshua is telling her, in no uncertain terms, that the inheritance stored up for the children of Israel cannot be given to anyone else but those exact children. Her answer is just as revealing. She says, "Truth, Lord, yet the dogs eat of the crumbs which fall from their masters' table." Note the location of the apostrophe in the word masters. It is plural! For once, the KJV translators got it right!!! She is acknowledging that the Israelites, not merely Jesus Christ, are her masters. The Canaanite woman understands that the children

of Israel are to inherit the Kingdom; and no one else has any claim to it. Because she acknowledged Him as the Son of David and because she acknowledged the Israelites as her masters, Yahshua granted her wish and even praised her for her "great faith." But He refused to give her what belongs only to the children of Israel.

Even the Edomite and Khazar Jews will ultimately acknowledge that we Anglo-Saxons are their Israelite masters. Just read Rev. 3:9.

Deut. 4:23-32 declares, through Moses the prophet, that at the Day of Judgment, He will regard Israel as a separate people, to be redeemed out of the nations among which they have been scattered:

I call heaven and earth to witness against you this day, that ye shall soon utterly perish from off the land whereunto ye go over Jordan to possess it; ye shall not prolong your days upon it, but shall utterly be destroyed. And the LORD shall scatter you among the nations, and ye shall be left few in number among the heathen, whither the LORD shall lead you. And there ye shall serve gods, the work of men's hands, wood and stone, which neither see, nor hear, nor eat, nor smell. But if from thence thou shalt seek the LORD thy God, thou shalt find him, if thou seek him with all thy heart and with all thy soul. When thou art in tribulation, and all these things are come upon thee, even in the latter days, if thou turn to the LORD thy God, and shalt be obedient unto his voice; (For the LORD thy God is a merciful God;) he will not forsake thee, neither destroy thee, nor forget the covenant of thy fathers which he sware unto them. For ask now of the days that are past, which were before thee, since the day that God created man upon the earth, and ask from the one side of heaven unto the other, whether there hath been any such thing as this great thing is, or hath been heard like it?

At Matt. 7:6, Jesus says, "Give not that which is holy unto the dogs, neither cast your pearls before swine, lest they trample them under their feet, and turn again and rend you."

What does this mean? 1.) We are not to give our Inheritance to non-Israelites. They have no part in the Covenants. 2.) When we intermarry with non-Whites, we give our inheritance to those who will abuse the covenants, thinking themselves better than us; and they will turn against us and kill us. This is what is happening in South Africa today, as the Judeo-Christians have tried mightily to convert the Blacks away from voodoo and their pagan, tribal beliefs, but it has not worked. This is also happening in all of the formerly White nations on planet earth, where the Jews have systematically disenfranchised White people and empowered non-Whites against us. Now, these same non-Whites, especially Blacks, Arabs, and Mexicans, pretend to be superior to Whites, even to the point of committing genocide against their White benefactors. Matt. 7:6 is a prophecy of what happens when we Israelites give our inheritance away to those who are not meant to have it. They are turning against us and rending us! We are not to mingle our seed with the non-White races. Whenever we do, Yahweh punishes us for disobeying His Law of Segregation.

The doctrine of racial integration is coming from the ENEMIES of God's People, Israel. These enemies are the Canaanite, Edomite, Khazar Jews, the Great Pretenders to the Inheritance of True Israel. This is what the Bible calls the GREAT HATRED (Psalm 139:22; Ezek. 36:5; Hos. 9:7), that was announced in Gen. 3:15 and is still the most powerful religious and political force operative in the world. It is Esau's HATRED of Jacob's posterity that is driving the Jews headlong towards judgment by Yahshua when He comes again. Contrary to the Word of God, the doctrine being preached from today's pulpits is *racial integration*!!!

"Cain's line continued to grow and later Nimrod picked up the religion which eventually became known as Babylon and Baal.

Esau married into this mixed line of Canaanites and became known as the Edomites.

Today this doctrine is being pushed by their descendants in modern day Talmudic Jewry, Free Masonry, Catholicism, Cabala-ism, and centralized in the United Nations.

The UN policy is 'The International Brown Man.'

These enemies of Christ and the Adam/Israel people are carrying the grudge of Esau and Cain. They both lost their rights to the blessing and the scepter. Now they do not want Jacob/Israel Adam to

have it. They know from experience with torture in their new world orders of Babylon, Medo-Persia, Greece and Rome that they cannot turn Adamic Israel Christians from their faith in God and Christ. Therefore, as Balaam told Balaak, the only avenue you have left to curse an Israelite is to get him to inter-racially fornicate and produce children in which God cannot live and function. They will automatically lose their right to be part of the kingdom and the redeemed.' – p. 20-21, The Bible and Race Relations, Dr. Everett Ramsey.

Remember the tower of Babel? Well, it was Satan's first attempt to create a multicultural, anti-Adamic "United Nations." That was why Yahweh disrupted their language, so they could not continue to conspire with Baal against us.

Dr. Ramsey's analysis is confirmed by the Book of Jubilees, where Rebecca says to Isaac, "And she went in to Isaac and said to him, 'One petition I ask of thee: Let Esau swear that he will not harm Jacob, and will not persecute him in enmity, for thou knowest the thoughts of Esau, that he was terrible from his youth on, and there is not gentleness in him; for he desires after thy death to kill him. And thou knowest how he has done all day, that HE HAS LEFT US WITH HIS WHOLE HEART, and does evil with us. He has collected thy flocks, and all the possessions HE ROBS FROM BEFORE THY FACE, and when we entreated and asked for what was ours, HE DID AS A MAN THAT PRACTICES USURY ON US."" – Jubilees, XXXV, 12-14.

Which ethnic group is most well-known, having no equal, for practicing USURY? Only we in Christian Israel know exactly who and what the Jews really are. The rest of the world still gropes through the murky matrix of Mystery Babylon, having made common cause with the Jews in making merchandise of True Israel. (John 2:16; 2 Peter 3.) Commerce by day, fornication by night, just as Esau, their mackdaddy, did ages ago. Barack Obama is nothing but the latest puppet of the Edomites. The Jews make merchandise of White Israelites, while the "Amen Corner" of Judeo-Christians cheer, "More! More!" "And they love to have its so!" The holier-than-thou "Christian" Zionist is asking for a double dose of judgment. They think and act like Jews, not even realizing their apostasy.

But, there is GOOD NEWS! The slow, gradual Awakening of True Israel is occurring, just as prophesied: "And it shall come to pass, in that day, that Yahweh shall beat off from the channel of the river unto the stream of Egypt, AND YE SHALL BE GATHERED <u>ONE BY ONE</u>, O ye children of Israel. And it shall come to pass in that day, that the great trumpet shall be blown, <u>and they shall come which were ready to perish in the land of Assyria</u>, and the outcasts of the land of Egypt, and shall worship Yahweh in the holy mount at Jerusalem." – Isa. 27:12-13.

This prophecy has absolutely NOTHING to do with the Jews, who do not even claim to have any connection with the Assyrian Captivity. Only the Anglo-Saxon Israelites are spoken of here, for it was OUR ancestors, our DIRECT Israelite ancestors, who crossed over the Caucasus Mountains and became known as the Caucasian People. "Wherefore come out from among them AND BE YE SEPARATE, saith Yahweh, AND TOUCH NOT THE UNCLEAN; and I will receive you, and will be a Father to you, and ye shall be my sons and daughters, saith Yahweh Almighty." – II Corinthians, 6:14-18.

Even the Bhagavad Gita, which is Indo-Aryan (Abrahamic) literature, condemns race-mixing: "In times of unrighteousness and disorder, women become corrupted; FROM THE CORRUPTION OF WOMEN COMES THE MIXING OF RACES; and from this comes all evil."
